BY-LAW NUMBER 2019-

A By-law of The Corporation of the City of Barrie to further amend By-law 2018-146, being a by-law to appoint members to various committees, boards and commissions.

WHEREAS, the Council of The Corporation of the City of Barrie may appoint representatives to various committees, boards and commissions;

AND WHEREAS, By-law 2018-146 was passed on the 17th day of December, 2018 concerning appointments to committees, boards and commissions;

AND WHEREAS, the Council of The Corporation of the City of Barrie adopted motion 19-G-033 to further amend By-law 2018-146;

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:
