### 19-G-034 CONFIDENTIAL LABOUR RELATIONS MATTER/EMPLOYEE NEGOTIATIONS MATTER - BPFFA LABOUR NEGOTIATIONS

That motion 19-G-034 of the General Committee Report dated February 11, 2019, being the confidential notes concerning the discussion of confidential labour relations matter/employee negotiations - BPFFA Labour Negotiations, be received. (File: H07) (HRS002-19)

## 19-G-035 LABOUR RELATIONS MATTER/EMPLOYEE NEGOTIATIONS MATTER BPFFA LABOUR NEGOTIATIONS

- 1. That the Mayor and City Clerk be authorized to execute the new January 1, 2019 to December 31, 2023 collective agreement between The Corporation of the City of Barrie and the Barrie Professional Fire Fighters Association (BPFFA), based upon the tentative settlement reached on January 21, 2019, which is within the parameters established by City Council.
- 2. That the Director of Human Resources, or his/her designate, be authorized to execute Letters of Understanding (LOUs) and/or Letters of Intent (LOIs) between The Corporation of the City of Barrie and the BPFFA to address matters such as legislative changes, clarification of the intent of the agreement language, changes resulting from the resolution of a grievance or a complaint, trial periods for pilots of new initiatives or to formalize plans with the Association.
