## SECTION "A"

## POTENTIAL HERITAGE REGISTER LISTING - 186 BLAKE STREET

S. Millson Taylor and L. Millson Taylor, joint property owners of 186 Blake Street, provided a brief historical overview of their residential property. Mr. and Ms. Millson Taylor requested that 186 Blake Street be added to the Barrie Heritage Register as a listed heritage property.

The Committee recommended adding 186 Blake Street to the Heritage Register.

The Heritage Barrie Committee met and recommends adoption of the following recommendation(s):

The Heritage Barrie Committee met and reports as follows:

## SECTION "C"

## DONATION REQUEST FROM THE BARRIE HISTORICAL ASSOCIATION

M. Fisher, President of the Barrie Historical Association, reviewed correspondence from the Barrie Historical Association dated October 24, 2017 regarding the installation of a heritage plaque in Kempenfelt Park to honour Sir James Gowan. Mr. Fisher explained that the Barrie Historical Association is requesting financial support from private donors in the amount of \$2,500.00 for the remaining cost of this project.

The Committee reviewed the Heritage Barrie Committee's budget for 2017. The Committee deferred this item to a future meeting for further discussion.

### HERITAGE BARRIE STRATEGY - UPDATE

R. White, Zoning Administrative Officer provided an update regarding the Draft Heritage Barrie Strategy. Mr. White noted that the Draft Heritage Strategy online survey closed on November 5, 2017. He advised that the Final Heritage Strategy Report including recommendations should be finalized by early January 2018.

The Committee reviewed proposed revisions to the Draft Heritage Strategy. G. Marek will compile the Committee's feedback regarding the Draft Heritage Strategy and submit it to the Planning and Building Services Department by November 14, 2017.

#### PROCESS TO REMOVE PROPERTIES FROM THE HERITAGE REGISTER

The Committee discussed the process to remove non-designated properties currently listed on the Barrie Heritage Register.

R. White, Zoning Administrative Officer clarified that property owners would need to wait six months after Council's decision before submitting a request to have their property delisted on the Barrie Heritage Register.

### HERITAGE BARRIE AWARDS

R. White, Zoning Administrative Officer provided an update regarding the 2018 Heritage Barrie Awards ceremony to be held on December 4, 2017 at 7:00 p.m. in the Council Chamber. Mr. White noted that photographs of the properties have been taken for inclusion in the presentation at the awards ceremony.

The Committee discussed the presentation schedule for the Heritage Barrie Awards ceremony.
