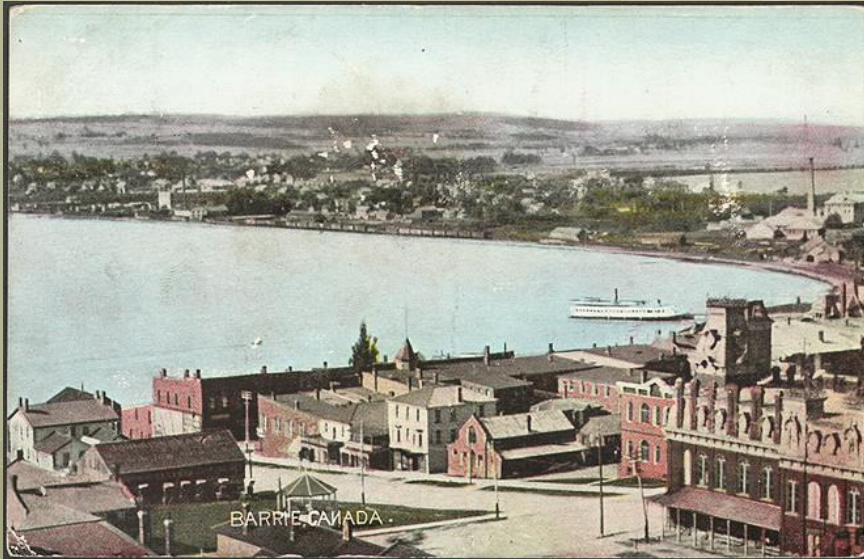

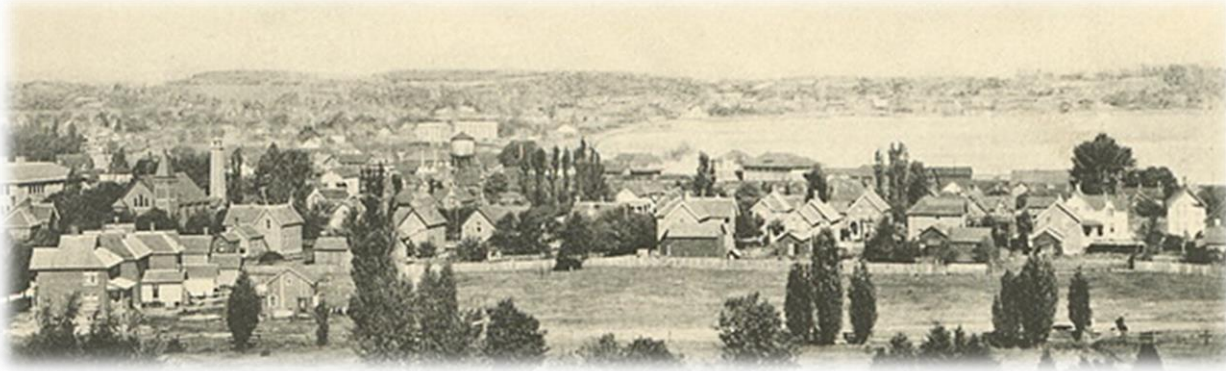

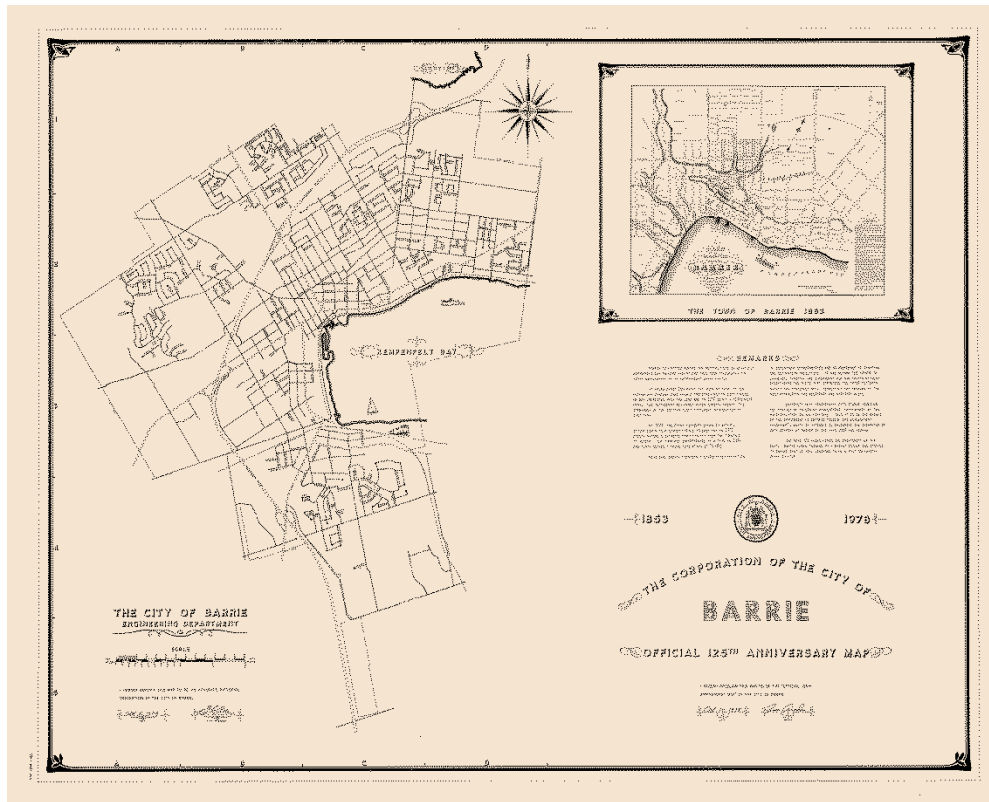

Purpose and Role of the City

Importance of Heritage

- Sense of place and belonging.
- Creates a strong sense of community identity, appreciation of diversity.
- Understanding the forces that shaped the City.
- Supports cultural, social and economic objectives.

Scope and Limitations

- Need to engage First Nations, Metis and indigenous peoples.
- A work-in-progress to be reviewed every 4 years.
- Starting point focuses on getting some basic processes, information, communication and awareness building in place.

Vision



The protection of heritage resources and their integration into daily lives is a matter of public interest and the City of Barrie is committed to the conservation, protection, enhancement, and celebration of the City's cultural heritage resources through:

- Continuous growth in understanding
- Protecting resources
- Supporting and encouraging stewardship and conservation practices
- Communicating and building public awareness

Knowing



Goals

- That there is continual growth in understanding and appreciation through ongoing identification and documentation.
- That significant and potential heritage resources are identified, their value understood and this information is publically accessible

Actions and Tasks

- Thematic history of the City of Barrie.
- Consolidate and compile information.
- Build the Municipal Heritage Register
 - Salem and Hewitt's Secondary Plan areas, Churches, Institutional sites and Historic Neighbourhoods.
- Maintain and map a database of registered archaeological reports prepared for development applications.
- Retain an in-house Heritage Planner.

Protecting



Goals

- To protect heritage resources including archaeological resources, heritage landscapes and built heritage.
- To develop policies to support decision making for heritage conservation, stewardship and heritage management.
- To protect enhance and improve heritage resources as a part of a strategic response to ongoing growth and development.

Managing



Goals

- To develop policies for heritage conservation, stewardship, and management of heritage resources within the City.
