RE: TEMPORARY PARKING CLOSURE ON COLLIER STREET BETWEEN POYNTZ STREET AND BERCZY STREET (WARD 2) (File: T02-PA)

DATE: JANUARY 21, 2019

The purpose of this Memorandum is to notify members of Council of the planned closure of on-street parking facilities (monthly parking pass type) on the north and south sides of Collier Street between the intersections of Poyntz Street and Berczy Street to facilitate infrastructure replacements by Alectra Utilities (Alectra). The closure of the parking facilities is confirmed to commence January 28, 2019 and be completed by February 25, 2019.

Motorists that have purchased monthly parking passes from the City of Barrie could be impacted throughout the duration of this work should they intend to park in the impacted area. Driveway access and utility services to businesses and residences in the impacted area will be maintained wherever possible. However, intermittent interruptions to access and/or electric service may be necessary for short durations due to the nature of the work. Alectra has committed to minimizing and notifying should these impacts become necessary.

One transit stop on Collier Street in proximity to Poyntz Street may also be affected by the work. The Transit group is working to determine if any changes may be necessary and will take action to inform transit users should this be necessary.

The City of Barrie Right of Way Activity (ROWA) group is working to post temporary 'no parking' signs during the work dates according to the City of Barrie Traffic By-law (By-law # 80-138). Additionally the ROWA group is asking that Alectra notify all impacted businesses/residents located on Collier Street in advance of the date of commencement through the use of electronic notice boards and a mail-out to residents. A copy of the notice to be provided by Alectra is attached to this memo.

In keeping with this commitment, Alectra Utilities will be replacing overhead equipment in your area. Further to communication you may have received from The City of Barrie, Alectra Utilities will be working on Collier Street between Poyntz Street and Berczy Street to accommodate the planned equipment replacement. Please see reverse for map of the affected area.

This project will require the relocation and replacement of Alectra equipment. Additionally, no parking in the permit parking spots on Collier Street has been arranged with the City of Barrie. Construction vehicles and equipment will be apparent and we apologize for any inconvenience this may cause. Alectra Utilities will adhere to best construction practices ensuring a safe work zone.

Furthermore, entrance to driveways may be impacted and every effort to coordinate safe vehicular passage during construction will be made.

Scheduled power interruptions may be required to safely complete the equipment replacement and every attempt will be made to notify you in advance of any interruption of hydro service.

Construction is scheduled to begin on, or about, January 28, 2019 and completion is expected on or about February 25, 2019.

Scheduled outage notification will be by phone, please ensure that your primary contact phone number attached to your Alectra Utilities account is current.
