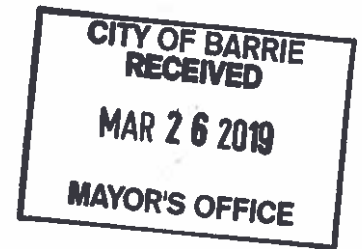

Dear Mayor Lehman and Council:

Re: Simcoe Muskoka District Health Unit Board of Health 2019 Funding Notice

The Simcoe Muskoka District Health Unit works with our communities, to prevent disease and injury, and promote and protect health for all in Simcoe Muskoka. Guided by a new vision, mission, values and strategic plan for 2019 -2022, the health unit will focus on three strategic priorities: relationships; public health standards; and accountability and governance. The 2019-2022 Strategic Plan is available online through our website www.simcoemuskokahealth.org, in the About Us section under Health Unit Profile.

On February 20, 2019 the Board of Health for the Simcoe Muskoka District Health Unit approved the 2019 base budget for cost shared and related public health programs at \$29,773,211. The total municipal levy for 2019 is \$8,167,011 which represents a 2 per cent increase over the 2018 municipal levy.

Under section 72 of the Health Protection and Promotion Act (HPPA), it is the responsibility of obligated municipalities in a public health unit to pay the expenses of a Medical Officer of Health (MOH) and the Board of Health (BOH). The proportion of the expenses of the Simcoe Muskoka District Health Unit paid by each obligated municipality is determined in accordance with Regulation 489/97 of the Health Protection and Promotion Act R.S.O.1990. The amounts due from each obligated municipality have been calculated using the Municipal Property Assessment Corporation's population and total assessment figures for 2018. The use of these figures is consistent with Regulation 489/97. Each obligated municipality's portion of the levy is shown in the following table:

For the City of Barrie, the 2019 monthly instalments, effective January 1, 2019 and the first of each month thereafter is \$145,048. There is currently a credit balance of \$428,829 for the first two months of this year. Please adjust your monthly payments accordingly.
