Constable Hale from the traffic unit attended to provide a demonstration of the Dragger 5000. This device is the only approved drug screening device which tests for drugs in saliva. This device only detects THC (Cannabis) and cocaine. The Barrie Police Service was able to buy this device with assistance of a provincial grant which cut the cost in half.

Councillor Shipley volunteered to assist with the demonstration, which took approximately 5 minutes to complete.
