The City is presently under taking Phases 3 and 4 of the Municipal Class Environmental Assessment (Class EA) process to assess the implementation of transportation improvements identified in the City's Transportation Master Plan (TMP) on Dunlop Street from Ferndale Drive to Anne Street.

The Transportation Master Plan (TMP) identified the need for additional general purpose lanes (3 east bound, 3 west bound) on Dunlop Street as compared to what is identified in MTO's Transportation Environmental Study Report (2 east bound, 2 west bound). MTO has agreed to work collaboratively with the City to incorporate the additional transportation improvements when reconstruction occurs subject to a completed Class EA study (and City funding).

A Public Information Centre (PIC) has been scheduled for the above noted project on Wednesday, June 19, 2019, in the City Hall Rotunda from 4:00 p.m. to 7:00 p.m.

The City of Barrie has initiated a Schedule 'C' Municipal Class Environmental Assessment (Class EA) study to address the current and future transportation needs for Dunlop Street West, from Ferndale Drive to Anne Street North. The purpose of this notice is to announce the study commencement and to invite all those interested in the study to attend the Public Information Centre (PIC). If you are a member of the public, you are receiving this letter because you own property or reside within the study area boundary.

Background

Phases 1 & 2 of the Class EA process for this study are addressed by the City's Transportation Master Plan (TMP). The TMP identifies transportation improvements along Dunlop Street West to accommodate planned growth to 2041 as per the Provincial Growth Plan for the Greater Golden Horseshoe.

Project Scope

This study will evaluate alternative design concepts within the study area (see reverse). The study will consider impacts to the natural, cultural, social and technical environments, gather input from agencies, affected groups and the general public within the study area, and document the planning and decision-making process in an Environmental Study Report (ESR).

Public Information Centre and Invitation for Comment

A Public Information Centre (PIC) will be held to provide information about this study, answer questions regarding the project, present conceptual street cross-sections and collect public input and comments. The PIC will be in the format of an informal drop-in session.


