

#### SUPERVISED CONSUMPTION SITES: KEY OUTCOMES



- 1. Prevent overdose deaths and unsafe injection practices
- 2. Increase access to health and social services, including addiction treatment
- 3. Decrease community harms and costs, including public injection and publicly-discarded needles

2,039 People completed the online survey

People with lived experience of drug use completed the survey with a community partner agency

24 Community stakeholders participated in consultations

# Potential Benefits of a SCS in Barrie (all sources combined)

- Reducing drug use in public
- Reducing risk of injury and death from drug overdose
- Reducing the number of used needles on the streets and in parks
- Help lower risk of diseases such as HIV, Hep C
- Help increase use of new drug-related equipment for each injection
- Act as a bridge to other services and connect clients to additional supports in the community
- Creating a safe and supportive environment for a client




#### Concerns of a SCS in Barrie (all sources combined)

- Encouraging more drug use
- More people who use drugs would be in the neighbourhood
- Safety of community members
- Potential for increase in crime and drug trafficking
- Increase in vulnerable population in the community

# **NEIGHBOURHOOD MEETING - MAY 15, 2019**



- Engagement and education were provided re: SCS location, operations and mitigation strategies
- 105 people attended
- Feedback received from participants through discussions and in writing
- Primary concerns of participants included:
  - Safety of residents in the neighboring community of the SCS, including seniors and young families
  - Safety concerns related to David Busby Centre clients will get worse with opening of SCS
- Some participants voiced support and encouraged urgent action:
  - "The consumption site was well thought out and I feel proud to be paying taxes towards this initiative. I hope that positive results will be shared with the community so that people can understand the good it does."

# Other Application Components

#### **SITE SELECTION - 90 MULCASTER ST**



#### **Key considerations:**

- Client access:
  - Within 1 km radius of where drug use occurs, and walking distance of open drug use
  - On a bus route
- Sensitive land uses:
  - No less than 100-200m from a child care centre/park/school
- Co-location with wrap-around services
- Suitable physical space
- Consultation feedback re: location

Gilbert Centre, Simcoe Muskoka District Health Unit Sexual Health Program

### **OPERATION OF THE SCS**



- Staff Model: 1 Registered Nurse, 2 Harm Reduction Workers, 1 Peer, and 1 Security Guard per shift plus casual staff as needed.
- Open 7 days a week, 0700 am- 0100 am
- 4 Injection Booths with a foot washing station, connected to the injection room
- Separate office space to provide onsite counselling/testing as well as wound care
- The SCS is approx. 1000 sq. ft.
- Operating annual budget approx. \$1.5 m
