He advised that he believes that the proposed neighbourhood renewal project for Frederick Street should take place as soon as possible. Mr. Harris indicated that he felt that policies that would provide a rebate for improvements to the sewer laterals would contribute to delays in completing the neighbourhood renewal project.
