#### **AWARDS AND RECOGNITION**

#### RECOGNITION OF SHANNON **BONNAR** AND DAVID WHITE, THE 18-A-082 RECIPIENTS OF THE GOVERNOR **GENERAL CANADA** OF **SOVEREIGN'S MEDAL FOR VOLUNTEERS**

Mayor Lehman recognized Shannon Bonnar and David White for receiving the Sovereign's Medal for Volunteers. He explained that the Sovereign's Medal for Volunteers is an award from the General Governor of Canada that recognizes the exceptional volunteer achievements of Canadians in a wide range of fields. Mayor Lehman shared that Ms. Bonnar received the award for her 22 years of volunteering as a Cadet instructor Cadre Officer over five different communities across Ontario. Mayor Lehman advised that Mr. White received his award for more than 10 years of organizing fundraisers to benefit school breakfast programs, preparing food hampers for families in need, as well as arranging transportation for families with children in hospital and for cancer patients travelling to and from medical appointments. Lehman congratulated Ms. Bonnar and Mr. White on receiving Sovereign's Medal for Volunteers and thanked them for their volunteer services in the community.

Councillor Shipley commented on the positive outlook Mr. Garvie has after hearing his story, his health concerns and Mr. Garvie want to give back to the community using his own bags garbage Councillor Shipley and tags. mentioned unfortunate accident when Mr. Garvie had been hit by a car resulting in

serious injuries and his scooter being written off and yet, his dedication and determination to give back to the community Mr. Garvie continue to pick up garbage as much as his health will permit. Councillor Shipley expressed that Mr. Garvie makes him proud that he lives in the City of Barrie.
