INVESTMENT MANAGEMENT PROGRAM: CONTEXT AND MANDATE

Thierry Rayaisse, Portfolio Manager provided an overview concerning the investment management program.

- The forecasting of the City's revenue and expenses based on the 2018 financial statements;
- Charts illustrating the 10 Year Capital Plan;
- A summary of the Prudent Investment Standard;
- Information associated to the Investment Policy Statement and the Investment Plan; and
- The next steps and timelines for the Investment Board.

The Board members asked a number of questions and received responses from City staff.
