#### **SECTION "A"**

The Heritage Barrie Committee met and reports as follows:

#### **DEVELOPMENT APPLICATIONS UNDER REVIEW - 147 TORONTO STREET**

The Committee met and discussed the development application which is under review for 147 Toronto Street. M. Johns provided the Committee with a brief background regarding the application.

B. Dee, Director of the Kiwanis Club detailed the history associated with the property at 147 Toronto Street. Mr. Dee noted that the Committee of Adjustment has deferred their decision pending the completion of a Heritage Impact Assessment Report by the Kiwanis Club. He requested the Committee's guidance pertaining to the assessment of the property, as there is uncertainty regarding its use. Mr. Dee noted that the Kiwanis Club has a tentative agreement for the purchase of the property without the woodlot and is concerned that if the severance is not approved this could affect the sale of the property.
