### **PRAYER FOR GUIDANCE BY MAYOR J. LEHMAN**

**Mayor J. Lehman opened the meeting with a prayer for guidance and welcomed the visitors in attendance.**

**SWEARING IN OF WARD 8 COUNCILLOR-ELECT ARIF KHAN****12-A-168**

Dawn McAlpine, City Clerk called upon Justice of the Peace, Brian Norton to administer the Declaration of Office Oath, to Ward 8 Councillor-Elect Arif Khan.

His Worship Norton administered the Declaration of Office Oath to Councillor-elect Arif Khan.

Councillor Khan assumed his seat at the Council table. On behalf of City Council, Mayor Lehman welcomed Councillor Khan to City Council.

Councillor Khan expressed his appreciation to his family and friends for their caring, encouragement and support. He thanked City staff for their graciousness and time in helping him prepare for his role over the past two weeks. Councillor Khan acknowledged the trust placed in him by the residents of Ward 8. He commented that he intends to be involved with the community and communicate on behalf of Ward 8 residents. Mayor Lehman congratulated Councillor Khan on the success of his campaign and his commitment to public service. **STUDENT MAYOR(S)****12-A-169**

John Sambrook Pett of Bear Creek Secondary School thanked City Council for the opportunity to serve as Student Mayor and thanked his civics teacher Mr. Rourke for introducing him to the program. He noted that he had no idea how City Council operated prior to his experience as Student Mayor. John shared his observations of City Council as a collection of people striving to make the City a better place through good decisions.

Caoimhe Walsh of St. Monica's Catholic School stated that she feels honoured to have participated in the Student Mayor Program. She commented that she has always had an interest in politics, including when she lived in Ireland. Caoimhe noted that she believes that Barrie is an amazing place to live and that she learned many things through her experience as Student Mayor. She thanked her teacher Ms. Davidson, her family, her fellow Student Mayor and her friends for their support. She concluded by extending best wishes to future Student Mayors

Mayor Lehman presented John and Caoimhe with certificates commemorating their terms of office as Student Mayors and thanked them for their participation in the Student Mayor Program.

## **AWARDS AND RECOGNITION**

**12-A-171** Carla Ladd, Chief Administrative Officer presented the Recycling Council of Ontario's (RCO) bronze 2012 Waste Minimization Award for Municipal Communications to the City of Barrie. She noted that the RCO is a not-for profit organization. She described the judging criteria and the evaluation process associated with the award. Ms. Ladd noted that the bronze award was presented to the City in recognition of its comprehensive waste reduction community programs, which covered all events for a full year.

Ms. Ladd presented the Municipal Waste Association's silver 2012 Promotion and Education Award to the City of Barrie in recognition of the 2012 Waste Reduction Calendar. She provided the judging criteria and highlighted the requirements for the award. She recognized the efforts of the staff in the Environmental Operations Branch. Ms. Ladd presented John Thompson, Director of Environmental Services with both awards. Mr. Thompson acknowledged the staff from the Environmental Operations Branch in attendance, Chris O'Neill, Tracy Quann-Strasser, Katherine Siren and Sandy Coulter. He read from a letter addressed to Chris O'Neill from Jim Bradley, Minister of the Environment, specifically acknowledging her efforts as well as those of the entire Environmental Operations Branch.

Mayor Lehman extended his appreciation to the Environmental Operations Branch staff and commented that the awards highlight the accomplishments of the City in improving the long term health and sustainability of the City.

**DEPUTATION(S) ON COMMITTEE REPORTS****12-A-172**

Darren Roskam provided a deputation to City Council in opposition to motion 12-G-333 concerning the City of Barrie Cultural Grants Program. Mr. Roskam congratulated Councillor Khan on his election as Ward 8 Councillor. He acknowledged the members of City Council who had addressed his concerns regarding the Cultural Grants Program. Mr. Roskam expressed concern regarding the issuance of previous individual artist grants, specifically related to the eligibility of individuals contracted by the City to receive cultural grants. He commented that he liked a number of the new provisions related to the eligibility criteria in the proposed recommendation, however, there were some he did not support. Mr. Roskam disagreed with comments made regarding an aspect of the rationale for the proposed changes to the program and stated that he believed the previous eligibility criteria made it possible for a jury to be compromised when making their decisions on the allocation of grants. He commented on a request to access specific grant applications that had been submitted. Mr. Roskam concluded by thanking City Council for their time and he encouraged Council to vote in favour of the changes to the program.

Brad Keast, Director of Development for Osmington Inc., provided a deputation to City Council in opposition to motion 12-G-354 concerning the Application for an Official Plan and Zoning By-law Amendment - North American (Park Place) Corporation - 100 Mapleview Drive East. He provided an overview of Osmington Inc. and the location of its property within the City of Barrie. Mr. Keast stated that Osmington Inc. is opposed to the recommended motion on the basis of fairness. He commented that he feels the Official Plan and Zoning By-law amendments for North American (Park Place) Corporation represent a wholesale change from the zoning previously approved by the Ontario Municipal Board. Mr. Keast explained that believes the proposed retail village has been pared back from the Ontario Municipal Board's approved conditions and suggested that City Council require North American (Park Place) Corporation to develop at least 50% of the retail village component instead of removing the phasing requirements. Mr. Keast listed the amendments and variances sought by North American (Park Place) Corporation since the Ontario Municipal Board had rendered its decision on their application, noting that the changes were a sign that the retail village concept was unrealistic.

Mr. Keast stated that the property Osmington Inc. owns has been zoned Commercial for approximately thirty years and that Osmington Inc. is waiting for Essa Road to be widened before their property can be developed. He observed that allowing the amendments to the North American (Park Place) Corporation property would result in the downgrading of the Osmington Inc. development. He displayed the proposed development plan for the Osmington Inc. site, indicating that he believes their property could be a catalyst for the development of the Essa Road corridor and the gateway to Downtown Barrie. Mr. Keast stated that the Park Place lands were not the only option for Target in Barrie. He explained that Osmington Inc. has been working with City staff and that the Essa Road widening will be complete by approximately the end of 2014, which would coincide with Target's plans. Mr. Keast concluded by encouraging City Council to require North American (Park Place) Corporation to develop what was promised through the Ontario Municipal Board decision.

Members of City Council asked a number of questions related to the deputation and received responses from the presenter and City staff.
