## RECOMMENDED MOTION

1. That Rates of Speed By-law 2002-191 Schedule "D", "Authorized Rates of Maximum Speed - 80 Kilometres per Hour" be amended by deleting the following:

Street From <u>To</u>

"Lockhart Road Huronia Road East Limits"

"Salem Road Highway 400 Veterans Drive"

"Veterans Drive 300 metres south of Mapleview Drive Salem Road"

2. That Rates of Speed By-law 2002-191 Schedule "C", "Authorized Rates of Maximum Speed – 60 Kilometres per Hour" be amended by deleting the following:

"Lockhart Road Highway 400 Huronia Road"

"Veterans Drive Essa Road 300 metres south of

Mapleview Drive"

"Yonge Street 28 metres North of Esther Drive A point 800 metres

## **PURPOSE & BACKGROUND**

- City staff have received a request regarding the existing 80 km/h posted speed limits on portions
  of Yonge Street and on Veterans Drive. These roadway segments transition from residential and
  commercial zones to rural areas which causes operational and safety concerns.
- 4. Lockhart Road is classified as a collector roadway and is a two (2) lane rural cross section between Highway 400 and Yonge Street with an existing posted speed limit of 60 km/h to the 2010 City limits transiting to 80 km/h to Yonge Street. Please refer to Appendix "A" for a map of the study area.
- 5. Salem Road is classified as an industrial local roadway and is a two (2) lane rural cross section between Highway 400 and Veteran's Drive with an existing posted speed limit of 80 km/h. Please refer to Appendix "B" for a map of the area.
- 6. Veterans Drive is classified as an arterial roadway and is a five (5) lane urban cross section between Essa Road and Salem Road with an existing speed limit of 60 km/h from Essa Road to a point 300 metres south of Mapleview, where it then becomes 80 km/h to the south City limits.. Please refer to Appendix "C" for a map of the study area.
- 7. Yonge Street is classified as an arterial roadway and is a two (2) lane roadway between Mapleview Drive East and Lockhart Road with an existing 60 km/hr from Esther Drive to a point 800 metres south of Mapleview Drive East where it then becomes 80 km/hr to Lockhart Road. Refer to Appendix "D" for a map of the study area.

## **ANALYSIS**

8. The purpose of this staff report was to review the existing geometric design and traffic operations of Yonge Street, Salem Road, and Veterans Drive and the existing posted speed limit of 80 km/hr to determine the feasibility of reducing the posted speed limit from 80 km/h to 60 km/h. As a result of this review staff recommending reducing the existing 80 km/h to 60 km/h to improve the operation and safety of the roadways.

## LOCKHART ROAD

9. Staff recommends that the existing posted speed of 80 km/h on Lockhart Road from the Highway 400 to Huronia Road be reduced to 60 km/h and extended to a point 975 metres west of 20th Side Road. This recommendation is based on the adoption of the Draft Secondary Plans with future residential development along Lockhart Road. Staff recommend that By-law 2002-191 be so amended.

#### **SALEM ROAD**

Staff recommends that the posted speed limit on Salem Road from Veteran's Drive and Salem Road to Highway 400 be reduced to 60 km/h. This recommendation is based on the adoption of the Draft Secondary Plans with future residential development along Lockhart Road. Staff recommend that By-law 2002-191 be so amended.

#### **VETERANS DRIVE**

Staff recommends that the existing posted speed limit of 60 km/h on Veteran's Drive be extended from the intersection of Veteran's Drive and King Street to the intersection of Veteran's Drive and Salem Road and that By-law 2002-191 be so amended.

12. The current transitional zone from 60 km/h to 80 km/h causes operational and safety concerns as it is located where Veteran's Drive transitions from a five (5) lane cross section with commercial blocks to a two (2) lane cross section with green space. The extension of the 60 km/h speed zone on Veteran's Drive will improve the operation and safety of the roadway by changing the transition zone further south away from the five (5) lane cross section with commercial blocks.

## YONGE STREET

- 13. Staff recommends that the existing posted speed limit of 60 km/h on Yonge Street be extended to Lockhart Road. This recommendation is based on the adoption of the Draft Secondary Plans with future residential development and that By-law 2002-191 be so amended.
- 14. Staff will continue to monitor the traffic operations on Yonge Street, Veteran's Drive, Lockhart Drive and Salem Road to ensure a successful transition.
- 15. Barrie Police Service and Barrie Fire & Emergency Service do not oppose staff's recommendation.

## **ENVIRONMENTAL MATTERS**

16. There are no environmental matters related to the recommendation.

## **ALTERNATIVE**

17. The following Alternatives are available for consideration by General Committee:

#### Alternative #1

General Committee could decide not to amend By-law 2002-191 and maintain the existing posted speed limit of 80 km/hr on Veteran's Drive.

This Alternative is not recommended as the current transitional zone from 60 km/h to 80 km/h causes operational and safety concerns as it is located where Veterans Drive transitions from a five (5) lane urban cross section to a two (2) lane rural cross section. The extension of the 60 km/h posted speed limit on Veterans Drive will improve the operation and safety of the roadway.

### Alternative #2

General Committee could decide to maintain the existing posted speed limit on Lockhart Road, Salem Road, and Yonge Street between Highway 400 and 20<sup>th</sup> Side Road.

This Alternative is not recommended based on the adoption of the Draft Secondary Plans with future residential development.

## **FINANCIAL**


18. The cost to install "Maximum Speed" signs is approximately \$2,000, which can be accommodated in the 2014 Operating Budget.

19. The recommendations included in this Staff Report are not specifically related to the goals identified in the 2010-2014 City Council Strategic Plan.






