YEAR END COMMUNICATION FROM DELOITTE LLP

Jesty, Paula Partner of Deloitte LLP reviewed the vear-end communication regarding the audit of the 2014 Consolidated Financial Statements with the Committee. She noted that the report summarized the findings from the audit which was conducted in accordance with the Audit Service Plan presented to the Finance and Corporate Services Committee on January 14, 2015.

Ms. Jesty reviewed key elements of the Audit including details of the following aspects:
