



**BY-LAW NUMBER 2015 -**

**A By-law of The Corporation of the City of Barrie to appoint  
Municipal Law Enforcement Officers as authorized under  
the provision of the Police Services Act.**

**WHEREAS**, pursuant to the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, the Council of any municipality may appoint Municipal Law Enforcement Officers who shall be Peace Officers for the purpose of enforcing the by-laws of the municipality;

**AND WHEREAS** Section 8 of the *Municipal Act, 2001*, S.O. 2001, c.25 ("the *Municipal Act, 2001*"), provides that the powers of a municipality under the *Municipal Act, 2001* or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

**AND WHEREAS** Section 9 of the *Municipal Act, 2001*, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** Section 10 of the *Municipal Act, 2001*, provides that a single-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction set out therein;

**AND WHEREAS**, pursuant to Section 227, of the *Municipal Act, 2001*, it is the role of the officers and employees of the municipality to implement council's decisions and establish administrative practices and procedures to carry out council's decisions; to undertake research and provide advice to council on the policies and programs of the municipality and to carry out other duties as required under this or any Act and other duties assigned by the municipality;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** Teresa Lynn Hannah Truen be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer.
2. **THAT** Mitchell Allan Douglas Franke be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
3. **THAT** Amber Marie Watson be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer
4. **THAT** Leah Kate Marie Ziliotto be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer
5. **THAT** Rita Anne Charest-Pekeski be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer
6. **THAT** Santana Marie Ferreira be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer
7. **THAT** Katie Ann Balch be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of her employment as a Municipal Law Enforcement Officer
8. **THAT** this By-law shall come into force and effect immediately upon the passing thereof.

**READ** a first and second time this 25<sup>th</sup> day of May, 2015.

**READ** a third time and finally passed this 25<sup>th</sup> day of May, 2015.
