**BY-LAW NUMBER 2016-**

**A By-law of The Corporation of the City of Barrie to permanently close the soil and freehold described as Part of Dunlop ST (closed by By-law 2547), Plan 2, Part of Lot 1, Plan 347, Part of Dunlop ST the Water Lots lying in front of Owen ST and Lots 8, 9 and 10, Plan 2 and Part of Lot 1, Plan 347, being designated as Parts 1, 2 & 3, Plan 51R-40518, known as Fred Grant Street.**

**WHEREAS** Section 9 of the *Municipal Act*, 2001, S.O. 2001, c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** pursuant to section 34 of the Act, the council of every municipality may pass by-laws to permanently close highways under the jurisdiction of the Municipality;

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 16-G-058;

**AND WHEREAS** Part of Dunlop ST (closed by By-law 2547), Plan 2, Part of Lot 1, Plan 347, Part of Dunlop ST the Water Lots lying in front of Owen ST and Lots 8, 9 and 10, Plan 2 and Part of Lot 1, Plan 347, being designated as Parts 1, 2 & 3, Plan 51R-40518, known as Fred Grant Street, is no longer required for highway purposes.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Part of Dunlop ST (closed by By-law 2547), Plan 2, Part of Lot 1, Plan 347, Part of Dunlop ST the Water Lots lying in front of Owen ST and Lots 8, 9 and 10, Plan 2 and Part of Lot 1, Plan 347, being designated as Parts 1, 2 & 3, Plan 51R-40518, known as Fred Grant Street, be and hereby is permanently closed.
2. **THAT** the City Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
3. **THAT** this by-law will have effect upon registration in the Land Registry Office of Simcoe County.
4. **THAT** Schedule "A" to this by-law, being an Affidavit of Wendy Chafe, sworn June 24<sup>th</sup>, 2016 forms a part of this by-law.

**READ** a first and second time this 27<sup>th</sup> day of June, 2016.

**READ** a third time and finally passed this 27<sup>th</sup> day of June, 2016.
