



**BY-LAW NUMBER 2014-**

**A By-law of The Corporation of the City of Barrie to acquire Pt Lt 7, Con 14, being Pt 1, 51R38679 and Pt Lts 16-22 inclusive, W/S Essa Rd, PL 30, being Pt 3, 51R38679 and Pt Lt 12 E/S Centre St, PL 30, being Part 30, 51R38679, City of Barrie, County of Simcoe from Essa and District Agricultural Society and to establish same as part of the municipal highway system.**

**WHEREAS** Section 10 of the Municipal Act, 2001, S.O. 2001, c. 25 (the "Act"), provides that a single tier Municipality may pass by-laws respecting matters set out therein, including, inter alia public assets of the municipality acquired for the purpose of exercising its authority under the Act or any other Act;

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 12-G-211;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to acquire Pt Lt 7, Con 14, being Pt 1, 51R38679 and Pt Lts 16-22 inclusive, W/S Essa Rd, PL 30, being Pt 3, 51R38679 and Pt Lt 12 E/S Centre St, PL 30, being Part 30, 51R38679, City of Barrie, County of Simcoe for road widening purposes from Essa and District Agricultural Society;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** The Corporation of the City of Barrie acquire Pt Lt 7, Con 14, being Pt 1, 51R38679 and Pt Lts 16-22 inclusive, W/S Essa Rd, PL 30, being Pt 3, 51R38679 and Pt Lt 12 E/S Centre St, PL 30, being Part 30, 51R38679, City of Barrie, County of Simcoe.
2. **THAT** Pt Lt 7, Con 14, being Pt 1, 51R38679 and Pt Lts 16-22 inclusive, W/S Essa Rd, PL 30, being Pt 3, 51R38679, City of Barrie, County of Simcoe be established as part of the municipal highway system and be named Essa Road.
3. **THAT** Pt Lt 12 E/S Centre St, PL 30, being Part 30, 51R38679, City of Barrie, County of Simcoe be established as part of the municipal highway system and be named Anne Street.
4. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 24<sup>th</sup> day of November, 2014.

**READ** a third time and finally passed this 24<sup>th</sup> day of November, 2014.
