Chair, Councillor Nixon confirmed with the Executive Director of Development Services that notification was conducted in accordance with the Planning Act.

The Affordability Committee met and reports as follows:

SECTION "A"

ZONING BY-LAW AMENDMENT - 264 SALEM ROAD (FILE: MDIR007-25)

The purpose of the Public Meeting is to review a Zoning By-law Amendment to permit a place of worship on lands known municipally as 264 Salem Road.

The Chair noted that the proposed Zoning By-law Amendment was introduced by Mayor Nuttall pursuant to Bill 3, the *Strong Mayors, Building Homes Act* which amended the *Municipal Act, 2001*, in accordance with subsection 284.11.1(1)(b) and 284.11.1(2), of the *Municipal Act, 2001*.

The chair advised that the purpose of the amendment is to permit the development of a place of worship.

Mayor Nuttall provided brief comments related to the by-law.
