**The Heritage Barrie Committee met and reports as follows:**

**SECTION "A"**

**DEVELOPMENT PROPOSAL FOR THE RELOCATION OF THE GREY AND SIMCOE FORESTERS REGIMENTAL MUSEUM - UPDATE**

J. Giaimo, Principal at Giaimo and Heritage Assessment Architect provided an update regarding the proposed relocation of the Armoury building located at 36 Mulcaster Street. He reviewed the recent history and current condition of the Armoury. Mr. Giaimo discussed the Conservation Strategy and four options concerning the proposed site placement of the Armoury.

Mr. Giaimo advised that the next steps will include preparing a final report regarding the proposed site placement of the Armoury. He noted that the final report will include details associated with the following:

- Site history;
- Architectural features;
- Building condition assessment;
- Proposed conservation strategy; and
- Heritage Impact Assessment.

Members of the Committee asked a number of questions related to the information provided and received responses from Mr. Giaimo and representatives from SOLUTIONS ink.

**HERITAGE EASEMENT WORKSHOP - UPDATE**

K. Brislin, Senior Policy Planner provided an update regarding her experience at the Heritage Easement Agreement Workshop held in Oakville, Ontario on July 8, 2016.

Ms. Brislin reviewed various types of Heritage Easement Agreements and the Heritage Easement Agreement process.

She stated that the deadline for submitting Heritage Barrie Award nominations is September 21, 2016. Ms. Brislin noted that she will compile the Heritage Barrie Award nominations for review at the next Heritage Barrie Committee meeting scheduled for October 4, 2016.

**PROMOTION OF HERITAGE IN BARRIE**

D. Warrilow provided suggestions and methods on how he feels heritage preservation could be promoted in the City of Barrie. The Committee discussed utilizing local media, conducting walkabouts in historic neighbourhoods, participating in Heritage events, promoting Ontario Heritage Week and developing a Heritage workshop.
