The Seniors and Accessibility Advisory Committee met and reports as follows:

### **ACCESSIBILITY AND AUTOMATED CART COLLECTION**

Stephanie Mack, Associate Director of Waste Management and Environmental Sustainability and Bridget Mitchell, Manager of Solid Waste Management Policy and Planning provided a presentation regarding the Accessibility and Automated Cart Collection program.

Ms. Mack and Ms. Mitchell discussed slides concerning the following:

- Automated cart collection program;
- Organics and garbage cart sizes available;
- Cart storage and cart limits based on number of residential units;
- Benefits of the carts and accessibility considerations; and
- Overview of the Assisted Waste Collection Program (in development)
