



**BY- LAW NUMBER 2014**

**A By-law of The Corporation of the City of Barrie to further amend By-law 2002-191 as amended, being a by-law to prescribe and authorize rates of speed within the City of Barrie.**

**WHEREAS** in accordance with Subsection 2 of Section 128 of The Highway Traffic Act (R.S.O. 1990, c.H.8) the council of a municipality may, for motor vehicles driven on a highway or portion of a highway under its jurisdiction, by by-law prescribe a rate of speed different from the rate set out in subsection (1) that is not greater than 100 kilometres per hour and may prescribe different rates of speed for different times of day;

**AND WHEREAS** the Council of The Corporation of the City of Barrie passed by-law 2002-191, being a by-law to prescribe and authorize rates of speed within the City of Barrie;

**AND WHEREAS** by motion 14-G-107, the Council of The Corporation of the City of Barrie deems it expedient to further amend By-law 2002-191 with respect to the flashing 40 km/hr signal zone on Anne Street.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** By-law 2002-191 Schedule "B", "Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/hr" be repealed and replaced with the Schedule "B", "Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/hr" attached hereto and forming part of this By-law.
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 2<sup>nd</sup> day of June 2014.

**READ** a third time and finally passed this 2<sup>nd</sup> day of June 2014.
