# **VEHICLE EMISSION CONTROLS PRESENTATION - DIESEL VS. GAS**

Peter Bursztyn, Chair provided the Committee with a presentation concerning Vehicle Emission Controls - Diesel vs. Gas.

#### DOG STRANGLING VINE DISCUSSION

The Committee discussed the Dog Strangling Vine spreading throughout the City. The Committee agreed that continuing education, mowing it back and monitoring the spreading of the Dog Strangling Vines could assist in managing the invasive species in the City of Barrie.

The Committee agreed to invite City Staff to attend a future meeting to receive an update regarding how the City manages the Dog Strangling Vine.

The Environmental Advisory Committee met and recommends adoption of the following recommendation:

#### **ENVIRONMENTAL HAZARD LABELS OF SAFETY DATA SHEETS**

- 1. That the City of Barrie investigates implementing the requirement to have its suppliers provide WHMIS 2015 Safety Data Sheets for Environmental Hazard classification.
- 2. That City Staff encourage its suppliers to complete Section 12, Ecological Information of the Environmental Hazard Safety Data Sheets.
