

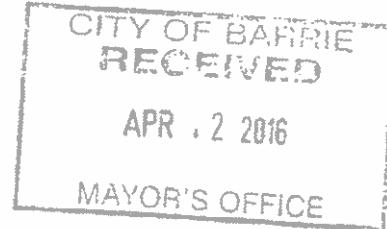

**MOTION:**

**WHEREAS** Casino Rama is one of the largest employers in Simcoe County;

**AND WHEREAS** over the last few years Casino Rama's Gross Revenues have declined due to additional competition allowed by Ontario Lottery and Gaming Corp. (OLG) in Ontario;

**AND WHEREAS** this increased competition has meant that employment at Casino Rama has been reduced, which has affected the local economy in the region;

**AND WHEREAS** OLG continues to invest in and strengthen competition in gaming that impacts Casino Rama, such as the proposed building of a new entertainment complex in one of the commercial casinos in Niagara Falls;

**AND WHEREAS** the new entertainment complex is expected to negatively impact Casino Rama and the local economy;

**AND WHEREAS** the Request for Prequalification (RFPQ) for Casino Niagara's proposed new entertainment complex has been released and the potential cost to build the new entertainment complex in the range of \$200 Million Dollars;

**AND WHEREAS** the OLG together with Rama First Nation completed a Development Plan in 2010, which included options to assist Casino Rama in growing its Gross Revenues, was an additional 300 room expansion along with expanded conference space that would allow for Casino Rama to remain competitive against the proposed new entertainment complex in Casino Niagara;

**THEREFORE BE IT RESOLVED** by a quorum of Chief and Council to request the OLG to stop the RFPQ at Niagara Falls; or in the alternative, suspend the new entertainment complex at Casino Niagara while the OLG revisits the Development Plan of 2010 - with a particular focus on the development of a Casino Rama conference centre - to assist Casino Rama to offset their potential loss in revenues, the potential reduction in employment and the potential negative effects on the local economy.
