## PRESENTATIONS

### 11-A-022 ROYAL VICTORIA HOSPITAL PROGRESS UPDATE

Mayor J. Lehman called upon Jon Babulic, Chair of the Royal Victoria Hospital (RVH) Board of Directors to introduce Scott Elliott, Vice Chair of the RVH Foundation, Janice Skot, President and Chief Executive Officer of RVH and Susanne Legue, Senior Director of Corporate Communications to provide a presentation to members of City Council concerning the Royal Victoria Hospital progress update.

S. Elliott thanked the City of Barrie on behalf of the staff and volunteers of RVH for the 52.5 million dollar investment the City of Barrie had made towards the RVH expansion project. S. Elliott noted at the time, the City had made the largest investment towards a hospital capital project in the province of Ontario. He commented that the City lead the way and started the "I Believe" Capital Campaign.

J. Skot provided an update regarding the Phase One Expansion Project. She recognized Councillor Prowse, Councillor Strachan and Councillor Ward who were City Council members in 2005 when the unanimous decision was made by Council to provide the grant funding. She provided photos of the construction site and noted that the expansion project, once complete will double the size of the hospital at a cost of 450 million dollars. She explained that after the renovation, the hospital will have the capacity for 165 new in-patient beds, a dedicated Coronary Care Unit, Expanded Emergency Department, Expanded Laboratory, Expanded Diagnostic Imaging Department, 2 new Operating Rooms, the Simcoe Muskoka Regional Cancer Care Centre and Rotary Place.

Ms. Skot provided a brief video created by Eye in the Sky Photography regarding the construction progress to date. She stated that the City of Barrie shares in the success of the project. Ms. Skot concluded that the construction should be complete at the end of 2011 with the grand opening to be held in the spring of 2012.

Mayor Lehman thanked the representatives from RVH for the presentation and acknowledged the 2003 to 2006 City Council for their vision in supporting the project.

### 11-A-023 HERITAGE OF THE ALLANDALE-BARRIE RAILWAY

Cathy Colebatch of the Allandale Neighbourhood Association introduced Mitchell Wilson of the Allandale Railway Historical Association and Bill Scott of the Allandale Neighbourhood Association. M. Wilson provided a presentation regarding the heritage of the Allandale-Barrie Railway. He provided a brief history of Ontario's first railway and explained how the railway was expanded then destroyed by a fire in 1894. M. Wilson noted that in 1905 the New Allandale Station complex was open and in 1922 the railway

was acquired by Canadian National Railway. M. Wilson described the decline of the railway. He concluded his presentation by noting that the City of Barrie purchased the Allandale Station from CN in 1997.

Ms. Colebatch commented that she believes the citizens of Barrie have an interest in the City's rail history and that Allandale Station has significant value to Barrie's history. Mr. Wilson stated that the Allandale Railway Historical Association would like a rail museum developed in the Allandale Station. In closing, Ms. Colebatch suggested that City Council consider naming the new GO Station as Allandale-Barrie or Barrie-Allandale to acknowledge the significance of Barrie's rail history.

Members of City Council asked a number of questions related to the presentation.

## **OPEN DELEGATIONS**

### **11-A-024 BARRIE WINDCATCHERS' PROPOSAL TO INSTALL A WIND TURBINE AT THE LANDFILL SITE**

Peter Bursztyn, Co-Chair of the Barrie WindCatchers addressed City Council to provide an open delegation concerning the Barrie WindCatchers' proposal to install a wind turbine at the landfill site. He requested that City Council consider the installation of the wind turbine in the near future and outlined that installing a wind turbine would add to the City of Barrie's long list of environmental initiatives, which he believes are not readily visible. He provided an overview of his views of the benefits of the wind turbine and urged City Council to consider the proposal.
