13. Revised 2019 Budget Operating and Capital Budget Request

The 2019 Budget has been revised as per a request from the City of Barrie to increase the 2019 contribution to the Radio System Upgrade Project, and the elimination of the Board Administrator position.

The percentage increase over 2018 remains the same at 2.8%, with the overall revised budget for 2019 being \$53,284,646. This represents a net increase of \$25,129 from the budget request approved by the Board on September 20, 2018.
