Recommendation(s):

- That the name of the right of way municipally known as Army, Navy and Air Force
 Drive be renamed to Vespra Street as shown on Appendix A attached to Staff Report
 DEV004-25, and that the properties fronting onto the renamed street with municipal
 address on this street, as shown on Appendix B to Staff Report DEV004-25, be also
 renumbered accordingly.
- 2. That, if approved, the following costs associated to the changes required as part of the renaming and renumbering of the properties on that portion of Army, Navy and Air Force Drive as shown on Appendix B attached to Staff Report DEV004-25, be assumed by the City of Barrie:
 - a) Installation of new street signs;
 - b) New street number signs for the existing buildings; and,
 - c) Any fee associated to changes on the systems of third parties.
- 3. To repeal By-law 2000-233.

Executive Summary:

The purpose of this staff report is to recommend a name change to the right of way known municipally as Army, Navy and Air Force Drive and described as Part Lot 25 Concession 6 Vespra; Part Reserve for Vespra Street Plan 211 Barrie Parts 1 & 2, 51R9157 Being Army, Navy, and Air Force Drive, as shown on Appendix A to Staff Report DEV004-25.

The renaming of this right-of-way from Army, Navy and Air Force Drive to Vespra Street will not negatively affect any businesses in the area but will resolve the concerns to the Harvest Bible Chapel owners as people still come to their doors asking about the ANAF Club.

Key Findings:

On March 11, 2024, Harvest Bible Chapel submitted a request to rename the street from Army, Navy and Air Force Drive to Vespra Street indicating that this street name is confusing as the ANAF Club is no longer on this property, noting they received walk-in inquires because the street name. This request is shown in Appendix D to Staff Report DEV004-25.

The Municipal Naming Working Group met to review the request for the renaming of the street from Army, Navy and Air Force Drive to Vespra Street and supported the recommendation to proceed with the name change if after public consultation no concerns were heard.

The right of way, currently known as Army, Navy and Air Force Drive, with an approximately 230m length, was originally part of Vespra Street as shown on Appendix C to Staff Report DEV004-25 - Registered Plan 211 and Plan 51R-9157. Vespra Street, a road in the City's road network identified as a local road on Map 4b of the Official Plan, runs in an East-West direction starting at Ellen Street in a western direction towards Anne Street South.

There are only two properties affected by this street name change, and one is a City-owned property as shown on Appendix B of Staff Report DEV004-25. The property known as 30 Army, Navy and Air Force is privately owned by the same owner of 23-25 George Street and 260 Vespra Street, and they do not use the address on Army, Navy and Air Force Drive for any purposes. The property known as 41 Army Navy and Air Force Drive is a City-owned property.

The other 3 properties located on the subject street do not require an address change as they are municipally addressed off surrounding streets as shown on Appendix B of Staff Report DEV004-25.

Financial Implications:

If the recommendations are approved as included in Staff Report DEV004-25, it is anticipated that there will be minor financial implications for the Corporation.

Where roads are renamed, the municipality must replace existing street signs at all road intersections as needed. In addition, the following costs for renaming and renumbering a property have been identified, and recommended to be covered by the City for the impacted parcels of land and any existing business:

- new street number sign(s) for the existing buildings; and,
- any fee associated to changes on the systems of third parties (e.g. Canada Post, Alectra).

Alternatives:

The following alternatives are available for consideration by General Committee:

Alternative #1 - General Committee could deny the recommendation of staff to investigate the street name change from Army, Navy and Air Force Drive to Vespra Street.

This alternative is not recommended as there has been a formal request made by the Harvest Bible Chapel and there is minimal impact to the other properties/businesses in the area.

Additional Background Information and Analysis:

By-law 2000-233 was passed by Council on October 16, 2000, to approve the name change of a part of Vespra Street to Army, Navy and Air Force Drive as shown on Appendix C to Staff Report DEV004-25.

This street name change was a result of a request submitted by the Army Navy and Air Force (ANAF) Club to commemorate and recognize those in the Armed Forces who served our Country. The ANAF Club was located at 7 George Street; a property with secondary frontage on the street known as Army Navy and Air Force Drive; however, no address was ever assigned to the property on this street.

In 2016 the ANAF Club sold this property at 7 George Street to the Harvest Bible Chapel and the club was relocated to 52 Morrow Road.

The Municipal Naming Policy, updated in January 2016, establishes the processes and criteria for naming, renaming, and dedicating Municipal Assets such as streets, parks and facilities as well as including the methods by which the public may provide suggestions and comments.

The Municipal Naming Policy establishes that the cost associated with a renaming (including but not limited to signage, legal costs, etc.) will be the responsibility of the City as the renaming has been agreed to by the City.

The City of Barrie proudly recognizes the vital contributions of Canadian Forces and its personnel to our community and nation. By way of the Cenotaph located at Memorial Square, Military Heritage Park located on the south shore of Kempenfelt Bay and naming streets to commemorate/ honour our fallen militaries.

The proper street naming and numbering signs ensure that our emergency services providers can locate a property as quickly as possible in an emergency and provides the foundation for locating properties in the City for all other purposes.

Therefore, if the renaming of the right of way from Army, Navy and Air Force Drive to Vespra Street, as shown on Appendix A, is approved, then properties on this road segment with street number on Army, Navy and Air Force Drive will need to be renumbered. By-law 2004-147 requires every property owner to post their municipal property number to be readily visible from the driveway connection to the road.

Consultation and Engagement:

Public consultation for the renaming of this street was given on January 7, 2025, and no concerns were raised.

A letter to the owners of the properties with access to this street was sent from the City to notify them of the intent to rename it from Army, Navy and Air Force Drive to Vespra Street, on January 30, 2025, and no concerns were raised.

Notification of the address changes as described on Appendix B of Staff Report DEV004-25 will be provided to property owners, all City departments, utility companies and other government agencies following the approval of the renaming of Army Navy and Air Force Drive to Vespra Street.

Environmental and Climate Change Impact Matters:

There are no environmental and/or climate change impact matters related to the recommendation.




