Committee Support Clerk, B. Thompson Manager of Business Performance and Environmental Sustainability, S. Brunet Manager of Parks and Forestry, K. Bradley. The Active Transportation and Sustainability Advisory Committee met and reports as follows:

CIRCULAR ECONOMY FRAMEWORK

Sandra Brunet, Manager of Business Performance and Environmental Sustainability provided a presentation on the Circular Economy: A New Approach to Waste Management.

Ms. Brunet discussed slides concerning the following topics:

- A reactive approach to traditional waste management reducing wastes in the landfill using the three R's: reduce, reuse, recycle, within a linear economy after it is created;
- The consequences of a linear economy;
- The Circular Economy: a proactive approach for waste by extending the use of existing resources and reduces waste;
- Influencing behaviours to make waste and associated emission reductions sustainable;
- An integrated approach to making Barrie's circular economy a reality;
- The implementation plan to move forward with various policies and procedures;
- The key challenges and opportunities for waste management; and
- The continual improvement requires for sustainability and resiliency.

Members of the Committee asked a number of questions Ms. Brunet and City staff and received responses.
