BY-LAW NUMBER 2012-

A By-law of The Corporation of the City of Barrie to acquire Part of Lots 6, 7, 8, 9 & 10 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 2, 3, 5, 6 & 7, Plan 51R38111, City of Barrie, County of Simcoe from Rockap Holdings Inc. and to establish same as part of the municipal highway system.

WHEREAS Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, inter alia, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act or any other Act;

AND WHEREAS the Council of The Corporation of the City of Barrie adopted Motion 06-G-524;

AND WHEREAS the Council of The Corporation of the City of Barrie deems it expedient to acquire Part of Lots 6, 7, 8, 9 & 10 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 2, 3, 5, 6 & 7, Plan 51R38111, City of Barrie, County of Simcoe for road widening purposes:

AND WHEREAS the Council of The Corporation of the City of Barrie deems it expedient to acquire Part of Lots 6, 7, 8, 9 & 10 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 2, 3, 5, 6 & 7, Plan 51R38111, City of Barrie, County of Simcoe and to establish same as part of the municipal highway system.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

- 1. **THAT** The Corporation of the City of Barrie acquire Part of Lots 6, 7, 8, 9 & 10 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 2, 3, 5, 6 & 7, Plan 51R38111, City of Barrie, County of Simcoe.
- 2. **THAT** Part of Lot 6 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 2 and 5, Plan 51R38111, City of Barrie, County of Simcoe be established as part of the municipal highway system and be named Sophia Street West.
- 3. **THAT** Part of Lots 6, 7, 8, 9 & 10 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Parts 3 and 7, Plan 51R38111, City of Barrie, County of Simcoe be established as part of the municipal highway system and be named Bayfield Street
- 4. **THAT** the northwest corner at the intersection of Bayfield Street and Sophia Street West be rounded over Part of Lot 6 W/S Bayfield Street, Plan 17, AKA Plan 121, designated as Part 6, Plan 51R38111, City of Barrie, County of Simcoe and be established as part of the municipal highway system.
- 5. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.
