#### **SENIOR HOUSING**

R. Cotton, Chair provided an update concerning Senior Rentals and Life Leases of Non-Governmental Non-Profit Housing Providers for 2015.

Mr. Cotton discussed information on new Senior Housing Rentals that are accepting applications for occupancy and housing for seniors concerning the Barrie Municipal Non Profit Housing Corporation (BMNPHC). He noted that the waitlist for senior housing is continuing to increase and at this time there are no future plans for additional buildings by the County of Simcoe nor the BMNPHC.
