Scott Drewette, Senior Asset Management Plan Program Coordinator provided a presentation concerning the 2025 Asset Management Plan Project Introduction.

PRESENTATION CONCERNING A PARKS, HORTICULTURE, FORESTRY, OPERATIONS SERVICE LEVEL REVIEW

Dave Friary, Director of Operations and Kevin Rankin, Manager of Parks and Forestry, provided a presentation concerning a Parks, Horticulture, Forestry, Operations Service Level Review.

Mr. Rankin discussed slides concerning the following topics:

- The Operations Department Staff Workforce Vision;
- An outline of the of the parkland, horticulture and forestry inventory;
- The four sections of the Parks and Forestry Operations Branch and staffing levels;
- An overview of the Service Level Review; and
- The City staff recommendations related to the Service Levels.

PARKS, HORTICULTURE AND FORESTRY SERVICE LEVEL REVIEW

- a) To assist City Council with the prioritization of services provided by the Branch;
- b) To allow for staff to develop budgets commensurate with Council's priorities and desired service levels;
- c) To prepare for anticipated growth or expansion of parks, trails, sport fields and courts; and
- d) To estimate Operational Costs as part of Staff Reports for new parks and park assets.
