**The Heritage Barrie Committee met and reports as follows:**

**SECTION "A"**

**OSMOND J. ROWE RECOGNITION - COMMEMORATIVE NAMING REQUEST**

K. Brislin, Senior Policy Planner reviewed the Municipal Naming Policy. Ms. Brislin noted that the Municipal Naming Policy establishes a comprehensive approach to the naming or renaming of municipal assets. Ms. Brislin reviewed the criteria for commemorative naming and the application process.

Ms. Ann Rowe provided a brief summary of the community contributions that her late husband, Osmond (Ossie) J. Rowe, made to the City of Barrie. Ms. Rowe asked that Mr. Ossie Rowe's community involvement be recognized by the City of Barrie.

**OSMOND J. ROWE RECOGNITION - COMMEMORATIVE NAMING**

That the Municipal Naming Working Group consider commemorating longtime Barrie Resident, Osmond (Ossie) J. Rowe's contribution to the Community in accordance with the Municipal Naming Policy.

**2016 WORK PLAN REVIEW**

C. Tribble reviewed the draft 2016 Heritage Barrie Committee Work Plan and the Committee provided their comments. Mr. Tribble requested Committee members to compile a list of work plan tasks for further discussion at the next meeting.

**PROCLAMATION REGARDING ONTARIO HERITAGE WEEK**

The Committee met and discussed the draft Proclamation request regarding Ontario Heritage Week. C. Tribble noted that Ontario Heritage Week takes place February 15 to February 21, 2016. He noted that this year's theme is the history of medical science and innovation in Ontario. Councillor Ward suggested including reference in the Proclamation to Dr. William Osler and Dr. William Gallie who were instrumental in the development of training programs for doctors and have a connection to the Barrie community.

**SIMCOE COUNTY HISTORICAL ASSOCIATION MEMBERSHIP RENEWAL**

C. Tribble advised the Committee that its membership with the Simcoe County Historical Association is up for renewal. Mr. Tribble noted that the annual membership fee for institutions is \$15.00. The Committee unanimously decided to renew the membership.

**DEVELOPMENT APPLICATIONS UNDER REVIEW**

K. Brislin, Senior Policy Planner provided an update regarding the proposed alterations to a designated property at 47 Rodney Street. Ms. Brislin noted that Council Motion 15-G-241 provided approval for the property owner, Su Murdoch, to proceed with the removal, replacement and alteration of the shed on her designated property in order to address structural issues.
