



BY-LAW NUMBER 2011-

A By-law of The Corporation of the City of Barrie to further amend By-law 80-138, as amended being a by-law to regulate traffic on highways.

WHEREAS Section 8 of the Municipal Act, 2001, S.O. 2001, c.25 ("the Municipal Act, 2001"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS Section 9 of the Municipal Act, 2001, provides that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities to (a) enable municipalities to govern their affairs as they consider appropriate and, (b) enhance their ability to respond to municipal issues;

AND WHEREAS Section 11 of the Municipal Act, 2001, provides that a single-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction set out therein, *inter alia* highways;

AND WHEREAS by motions 11-G-222, 11-G-223 and 11-G-224 it is deemed expedient that the Council of The Corporation of the City of Barrie further amend By-law 80-138 as amended, being a by-law to regulate traffic on highways.

NOW THEREFORE the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law 80-138, "**Schedule "A" – No Parking Any Time**" be amended by adding the following:

<u>COLUMN 1</u>	<u>COLUMN 2</u>
<u>"GLENWOOD DRIVE</u>	Both sides from Argyle Road to Bayfield Street
<u>GLENWOOD DRIVE</u>	West Side from Argyle Road to Cundles Road East
<u>MARGARET DRIVE</u>	East Side from Livingstone Street East to Nicole Marie Avenue
<u>MARGARET DRIVE</u>	West Side from Livingstone Street East to a point 30 metres north thereof
<u>WEATHERUP CRESCENT (WEST LEG)</u>	East Side from a point 107 metres north of Livingstone Street West to a point 33 metres north and east thereof
<u>WEATHERUP CRESCENT (EAST LEG)</u>	West Side from a point 160 metres north of Livingstone Street West to a point 47 metres north and we thereof
<u>WEATHERUP CRESCENT (WEST LEG)</u>	Both Sides from Livingstone Street West to a point 30 metres north thereof
<u>WEATHERUP CRESCENT (EAST LEG)</u>	Both Sides from Livingstone Street West to a point 30 metres north thereof".

2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

READ a first and second time this 12th day of September, 2011.

READ a third time and finally passed this 12th day of September, 2011.
