**BY-LAW NUMBER 2012 -**

**A By-law of The Corporation of the City of Barrie to appoint  
Municipal Law Enforcement Officers as authorized under  
the provision of the Police Services Act.**

**WHEREAS**, pursuant to the Police Services Act, R.S.O. 1990, c. P.15, as amended, the Council of any municipality may appoint Municipal Law Enforcement Officers who shall be Peace Officers for the purpose of enforcing the by-laws of the municipality;

**AND WHEREAS** Section 8 of the Municipal Act, 2001, S.O. 2001, c.M.25 ("the Municipal Act, 2001"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** Section 9 of the Municipal Act, 2001, provides that Sections 8 and 11 shall be interpreted broadly so as to confer broad authority on municipalities to (a) enable municipalities to govern their affairs as they consider appropriate and, (b) enhance their ability to respond to municipal issues;

**AND WHEREAS** Section 10, of the *Municipal Act, 2001*, provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

**AND WHEREAS**, pursuant to Section 227, of the Municipal Act, 2001, it is the role of the officers and employees of the municipality to implement council's decisions and establish administrative practices and procedures to carry out council's decisions; to undertake research and provide advice to council on the policies and programs of the municipality and to carry out other duties as required under this or any Act and other duties assigned by the municipality;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** Christopher Floyd Pearson be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
2. **THAT** Robert Lawrence Kennedy be appointed as a Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P. 15, as amended for the City of Barrie for the term of his employment as a Municipal Law Enforcement Officer.
3. **THAT** this by-law shall come into force and effect immediately upon the passing thereof.

**READ** a first and second time this 1<sup>st</sup> day of October, 2012.

**READ** a third time and finally passed this 1<sup>st</sup> day of October, 2012.
