The Town and Gown Committee met and reports as follows:

GENERAL UPDATES

- V. Cyr, Zoning Officer of the Planning and Building Services Department provided an overview of zoning enforcement responsibilities. Ms. Cyr noted that Zoning Enforcement staff often work in conjunction with the Barrie Fire and Emergency Service and/or the Property Standards Branch during investigations. She noted that Zoning Officers respond to resident complaints regarding the following:
 - Illegal two-unit housing registrations;
 - · Boarding, Lodging and Rooming Houses;
 - Front yard parking at residential homes; and
 - · Fence viewing.
- V. Cyr, Zoning Officer reviewed the different functions of the Property Standards Branch and Zoning Enforcement. Ms. Cyr clarified that if Barrie citizens have a complaint regarding a vehicle parked on a residential lawn that they contact Zoning Enforcement; however, complaints regarding a dilapidated vehicle in a residential driveway should be directed to the Property Standards Branch.
- R. Osborne, Supervisor of By-law Services provided a departmental overview. Mr. Osborne noted that training has been completed for the contracted staff hired to enforce overnight parking restrictions during the winter months. He provided an update regarding the service fees charged year-to-date by the By-law Services Branch.
- M. Kalyaniwalla, Manager of Sustainable Development of the Planning and Building Services Department described the different zoning classifications within the City of Barrie.
- Sergeant J. Brooks of the Barrie Police Service provided updates concerning community and student issues in Ward One.
