The Finance and Corporate Services Committee met and report as follows:

SECTION "A"

PRESENTATION CONCERNING THE MADY CENTRE FOR THE PERFORMING ARTS AND GEORGIAN THEATRE PROGRAMMING

Ms. Onalee Groves, Manager of Culture provided a presentation concerning the Mady Centre for the Performing Arts (Mady Centre) and the Georgian Theatre programming.

Ms. Groves discussed slides concerning the following topics:

- The background associated with increasing the use of the Performing Arts Centres in Barrie;
- A summary of the total days booked in 2015 and 2016 at each of the Performing Arts Centres;
- The components of the plan to increase the use of the Performing Arts Centres in Barrie as follows:

Part I:

 The addition of new fees for corporate functions and rentals at the Centres;

Part II:

 The programming opportunities identified at the Ontario Presents (Ontario Contact) Annual Conference;

Part III:

- The partnerships with other municipal theatres staff at the Orillia Opera House, Gravenhurst Opera House and Theatre Collingwood to book several shows;
- A listing of the new theatres bookings in 2017 and associated costs;
- The details of the financial risks associated with booked shows at the Centres;
- The building and nurturing of community relationships;

Part IV:

 Educational opportunities associated with utilizing at the Mady Centre as incubator space;

Part V:

- Promoting the theatre and cultural spaces through Spacefinders Simcoe; and
- The plan to mitigate the risks associated with the new theatre and feedback related to programming.

In closing, Ms. Groves requested the Committee's support and feedback related to programing.

Members of the Committee asked a number of questions and received responses from City staff.

PRESENTATION CONCERNING GOVERNANCE, RISK MANAGEMENT AND CONTROL PROCESSES

Ms. Sarah MacGregor, Director of Internal Audit provided a presentation concerning Governance, Risk Management and Control Processes.

Ms. MacGregor discussed slides concerning the following topics:

- The purpose of Internal Audit:
- Effective oversight;
- Internal Audit's role related to the Finance and Corporate Services Committee with effective oversight;
- Definition of governance, risk management and controls; and

PRESENTATION CONCERNING A POTENTIAL PARTNERSHIP AND INVESTMENT IN THE BARRIE HISTORICAL ARCHIVE

Dr. Travis Doucette, Chairman of the Barrie Historical Archive, provided a presentation concerning the Barrie Historical Archive and a request to partner with the City of Barrie to innovate ways to preserve, promote and protect the City's great history.

Dr. Doucette discussed slides concerning the following topics:

- The importance of photographs illustrating Barrie's past and resilience;
- A request for funding from the City of Barrie to underwrite the yearly expenses of the Barrie Historical Archive;

- The current funding that the City of Barrie invests related to historical preservation; and
- The benefits associated with the City of Barrie investing in the Barrie Historical Archive.

Dr. Doucette advised that the online archive has grown over the last year and has proven to have a positive impact on the community.

In closing, Dr. Doucette noted that the continued support of City staff and the members of Council has contributed to the Barrie Historical Archive's success. He stated that the Archive is interested in continued growth to preserve and proclaim the City of Barrie's history.

- 3. That a Request for Proposals be issued to engage a consultant for the Sponsorship Pilot Program based on the criteria and assets identified in Appendices "A" and "B" (as amended) to the report of the Finance and Corporate Services Committee.

- 4. That staff report back to General Committee regarding all opportunities involving the direct naming and renaming of City property, buildings and structures.
- 5. That Invest Barrie and Access Barrie staff be authorized to undertake a non-standard procurement process to allow for negotiations for naming rights with new, potential sponsors of the Mady Theatre and report back to General Committee with a recommendation. (16-G-273) (INV001-16) (File: M00)
