Mayor Lehman recognized the passing of former Mayor Willard Kinzie. Mayor Lehman shared that former Mayor Kinzie served as Mayor of Barrie from 1957 to 1961 and it was during his term in office that Barrie officially became a City. The Mayor spoke about former Mayor Kinzie's vision for the waterfront and how this legacy delights people and defines the City. Mayor Lehman also shared former Mayor Kinzie's love of trails and history, with both being combined on Barrie's waterfront for an open air, self-guided interpretive experience. Mayor Lehman commented that the City of Barrie has lost one of its greatest leaders and champions.

AWARDS AND RECOGNITION**18-A-089 PRESENTATION TO THE WINNER OF THE 2018 MAYOR'S CHRISTMAS CARD CONTEST**

Mayor Lehman called upon Alina Dion, the Winner of the 2018 Mayor's Christmas Card contest for her illustration entitled "Olde Tyme Barrie Christmas". Mayor Lehman advised that his office received numerous submissions and that Ms. Dion's mixed media painting depicting an older home on Dunlop Street decorated for the Christmas Season clearly stood out. Mayor Lehman advised that the painting will be displayed in City Hall and thanked Ms. Dion for sharing her talent.

18-A-090 PRESENTATION TO THE RECIPIENTS OF THE ORDER OF THE SPIRIT CATCHER AND YOUTH SPIRIT CATCHER AWARD

Councillor B. Ward and Councillor S. Trotter on behalf of the Order of the Spirit Catcher Committee announced that the Order of the Spirit Catcher and Youth Spirit Catcher Award are the highest awards presented in the City of Barrie and they noted that the recipients were recognized at a gala held by the Barrie Community Foundation.

Councillor Ward discussed the number of applications received. He noted that the contributions of those who were nominated were inspiring. Councillor Ward discussed the nomination process and the surprise experienced by the recipients when they are notified that they are to receive these awards.

Youth Spirit Catcher

Councillor S. Trotter announced that the recipient for the 2018 Youth Spirit Catcher Award was Mr. Jake Vaz. He advised that Jake Vaz has demonstrated leadership in the creation and execution of a chess program for children at the Barrie Public Library for the last four years.

Councillor Trotter shared that at the age of 14 Jake brought his idea to the Barrie Public Library and worked with staff to organize the program, and he noted that through Jake's unwavering commitment, the program flourished. Councillor Trotter noted that there have been many occasions when Jake has facilitated the program with more than twenty children playing at once.

Councillor S. Trotter invited Jake's grandfather Nolasco Hernandez to the podium to receive the 2018 Youth Spirit Catcher Award on behalf of Jake Vaz.

Mr. Hernandez extended thanks, on behalf of Jake who is away at school, for the recognition.

Order of the Spirit Catcher

Councillor Ward announced that the recipient of the 2018 Order of the Spirit Catcher Award was Mr. William Dwyer. He advised that Mr. Dwyer received multiple nominations for his volunteer and fundraising efforts over the years.

Councillor Ward shared that Mr. Dwyer has been a tireless volunteer for the Terry Fox Foundation for decades and has raised over \$800,000 to date and noted that his is to raise \$1,000,000. He discussed the ways that Mr. Dwyer has donated his time, talent and treasure to his Parish community and also the Barrie community at large. Councillor Ward commented that his work exemplifies the traits and qualities identified for the Order of the Spirit Catcher Award. Councillor Ward shared how Mr. Dwyer has been a faithful

volunteer during The Salvation Army's annual Christmas Kettle Campaign, standing at one of the iconic Christmas Kettles during the months of November and December for the last six years. Councillor Ward indicated that Mr. Dwyer has volunteered for the Royal Canadian Legion during their annual poppy campaign and has collected donations for the Parkinson's Society.

Councillor Ward invited Mr. William Dwyer to the podium to receive the 2018 Order of the Spirit Catcher Award.

Mr. Dwyer shared that he is only \$144,000 away from his goal of \$1,000,000 for the Terry Fox Foundation. He expressed his appreciation for being recognized and awarded the 2018 Order of the Spirit Catcher Award.

Mayor Lehman commented that both recipients are an inspiration to the community and were well-deserving of having their efforts recognized.

18-A-091 PRESENTATION TO THE RECIPIENTS OF 2018 HERITAGE BARRIE AWARDS

Mr. Chris Tribble, Chair of the Heritage Barrie Committee introduced the seventh annual Heritage Barrie Awards. He shared that the Heritage Barrie Committee selected winners from residential, commercial, institutional and group categories. Mr. Tribble, Mayor J. Lehman and members of the Heritage Barrie Committee presented awards to the following recipients:

Mayor J. Lehman thanked the members of the Heritage Barrie Committee and the recipients of the awards. He commented how great it is to see people take great pride in heritage preservation.

Mayor Lehman recognized the accomplishments of the outgoing members of Council who were present at the meeting.

Mayor Lehman recognized that Councillor Bonnie Ainsworth served four terms on City Council, including 1998-2000, 2001-2003, 2010-2014 and 2014-2018. He noted some of the Committees that Councillor Ainsworth was involved with during her Council terms. Mayor Lehman noted that a person would always know where Councillor Ainsworth stood on a matter. Mayor Lehman highlighted her desire to preserve the character of the east end of the City and how she was a champion for the improvement of roads.

Mayor Lehman presented Councillor Ainsworth with a framed print of the Duckworth Street road design, along with an actual piece of asphalt from Duckworth Street.

Councillor Ainsworth shared how she loved being a City Councillor, but noted that she believed it was time to move on. She commented that Councillors need to stand up for the people who elected them. She shared her feelings associated with her feeling that it was an honour to help and serve the community. Councillor Ainsworth thanked Mayor Lehman for his leadership over the last term of Council.

Mayor Lehman recognized Councillor Rose Romita's term on Council from 2014-2018. He noted that in addition to Council and numerous Committee responsibilities, she was a downtown business owner, an advocate for the homeless and hosts a Christmas Dinner program that is eagerly awaited by the community annually.

Mayor Lehman presented Councillor Ainsworth with an aerial photo of Ward 2 from Eye in the Sky Photography.

Councillor Romita shared her feelings associated with it being a pleasure and honour to serve on Council. She indicated she will continue with her Christmas dinner and advocating for the homeless. Councillor Romita thanked staff for their assistance over her term on Council.

Mayor Lehman recognized Councillor Steve Trotter for serving five terms on Council spanning 1995 - 2018. He noted that in July 2017 Councillor Trotter was appointed to replace Michael Prowse on Council. The Mayor highlighted Councillor Trotter's deep knowledge of the City, detailed work on Ward issues, making sure to follow up on matters and the importance of seeing the big picture.

Mayor Lehman presented Councillor Trotter with a framed print showing the historic map of Barrie from the City's 150th Anniversary along with a plan of the City from the mid-19th century.

Councillor Trotter shared that it has been an honour to serve on Council again and noted how after 25 years he has come full circle back to Ward 6. He spoke about how serving on Council is not about politics, but about building community and listening to what people want and what they are saying.

Mayor Lehman recognized Councillor Arif Khan for serving two terms on Council starting with the 2012 by-election and the 2014-2018 term. The Mayor noted Councillor Khan immersed himself in the work of City Council and Committees, while still continuing with volunteer work and coaching youth sports. He noted that Councillor Khan always supported community events and demonstrated clear leadership during the Little Avenue fire in the spring of 2018. The Mayor also noted that in today's age of sound bites and tweets, you always got the full answer and complete sentences from Councillor Khan.

Mayor Lehman presented Councillor Khan with a framed print of the road design for the Harvie Road / Big Bay Point Road Highway 400 Crossing, along with a microphone.

Councillor Khan shared how he has cherished the experience of being on City Council. He encouraged the future Council to be bold; challenge staff, but trust them; challenge developers and builder to raise the bar as buildings will be here for a century. He commented that Council should make their mark, while not undoing progress and to finish what has been started and to go after what they want, while continuing to be respectful.

Mayor Lehman concluded the Council Service Awards by thanking all outgoing Councillors for their service and dedication to the City of Barrie. He noted that all of Council believes in the City and are committed to the work of the City.

- Renderings illustrating parking, greenspace, elevations, lighting and future expansion areas;
- Renderings illustrating various perspectives of the building and landscaping; and
- The contact information for the project and community outreach completed to date.

Members of General Committee asked a number of questions related to the presentation and received responses from City staff.
