**BY-LAW NUMBER 2017-**

**A By-law of The Corporation of the City of Barrie to amend By-law 2009-141, a land use control by-law to regulate the use of land, and the erection, use, bulk, height, location and spacing of buildings and structures in the City of Barrie.**

**WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to amend By-law 2009-141 to rezone Part of Lot 2, Concession 14, and all of Blocks 160, 161, 162, 163 and 164 on Plan 51M-867, City of Barrie, County of Simcoe, more particularly described in Schedule "A" attached, from Agriculture (A) and Environmental Protection (EP) to Residential Single Detached (R3), Residential Medium Density (RM2) and Environmental Protection (EP).

**AND WHEREAS** the Council of The Corporation of the City of Barrie adopted Motion 17-G-130.

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** the zoning map is amended to change the zoning of Part of Lot 2, Concession 14, and all of Blocks 160, 161, 162, 163 and 164 on Plan 51M-867, City of Barrie, County of Simcoe, more particularly described in Schedule "A" attached, from Agriculture (A) and Environmental Protection (EP) to Residential Single Detached (R3), Residential Medium Density (RM2) and Environmental Protection (EP) in accordance with Schedule "B" attached to this By-law being a portion of the zoning map.
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 5<sup>th</sup> day of June, 2017.

**READ** a third time and finally passed this 5<sup>th</sup> day of June, 2017.

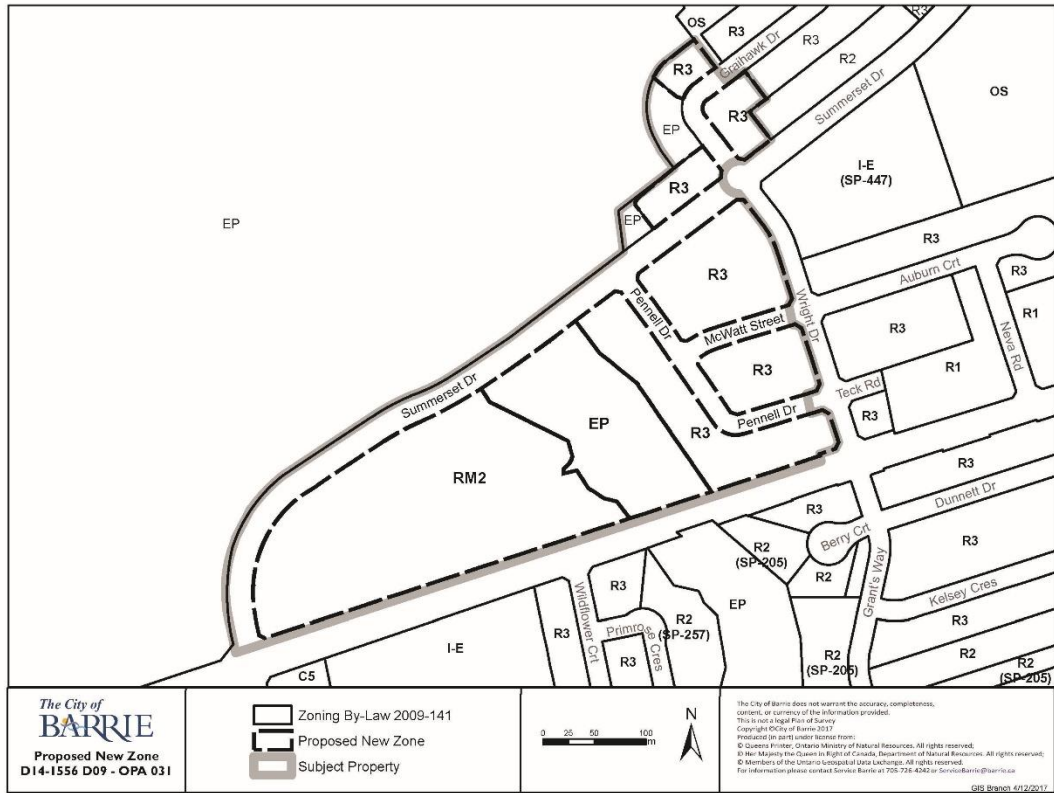
