

# LEGISLATIVE REQUIREMENTS

- Municipalities are required to develop and adopt a community safety and well-being plan by January 2021
- Appoint a multi-sectoral committee
- Other requirements include:
  - Public consultation
  - Content of the plan
  - Monitoring, evaluation and reporting

Approach provides for municipality to take leadership role working with these groups to ensure vulnerable populations receive assistance from providers best suited for support

# PURPOSE OF THE PLAN

The purpose of the plan is for municipalities and their community partners to refocus existing efforts in a more strategic and impactful way to enhance collaboration, information sharing and performance measurement.

# STRUCTURE OF THE PLAN

The plan should include:

- A well rounded approach to community safety and well-being
- Three to Five different themes with varying areas of community focus
- Three action items under each theme
- Action items must be measurable
- Alignment with World Council on City Data where possible
