**TAKE NOTICE** that an application has been received from **MHBC Planning c/o Jillian Sparrow on behalf of Caplan-Barrie Holdings Limited c/o Jens Zentil** for consent under Section 53 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended for a consent to a conveyance of property.

**IN THE MATTER OF** the premises legally described as PART BLOCK A PLAN 51M-495, BEING PART 7 PLAN 51R-42643 and known municipally as **150 Caplan Avenue** in the City of Barrie.

The property is zoned Business Park – Special Provision No. 338 (BP)(SP-338).

The application, if granted by the Committee of Adjustment, will serve to permit the creation of a new lot.

The severed lands propose to have a lot area of 13,909.61 square metres and a proposed lot frontage of 81.5 metres on Caplan Avenue.

The retained lands propose to have a lot area of 13,956.22 square metres and a proposed lot frontage of 86.7 metres on Caplan Avenue.

**TAKE FURTHER NOTICE** that the Committee of Adjustment public hearing has been scheduled for **Tuesday, June 24, 2025**. This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence, and you will receive no further notice. You must register and attend the hearing to receive further notice.

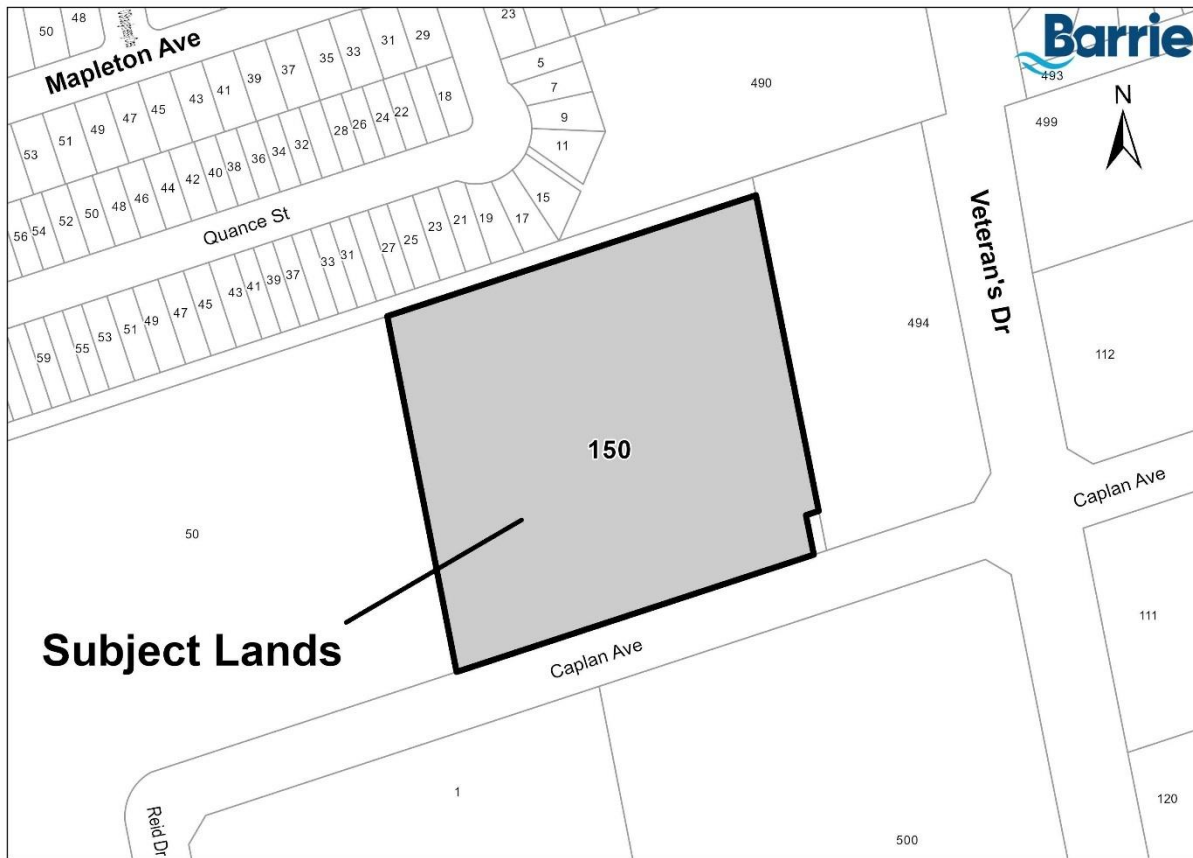
