

BY-LAW NUMBER 2015-

A By-law of The Corporation of the City of Barrie to amend By-law 2015-018, being a by-law to appoint members to various committees, boards and commissions

WHEREAS, the Council of The Corporation of the City of Barrie may appoint representatives to various committees, boards and commissions;

AND WHEREAS, By-law 2015-018 was passed on the 9th day of March, 2015 concerning appointments to committees, boards and commissions;
