



**BY-LAW NUMBER 2015-**

**A By-law of The Corporation of the City of Barrie to further amend By-law 80-138, as amended, being a By-law to regulate traffic on highways.**

**WHEREAS** Section 8 of the *Municipal Act, 2001*, S.O. 2001, c.25, (“the Municipal Act, 2001”) provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality’s ability to respond to municipal issues;

**AND WHEREAS** Section 9 of the *Municipal Act, 2001*, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** Section 10 of the *Municipal Act, 2001*, provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public, *inter alia* highways;

**AND WHEREAS** by resolution 15-A-\_\_\_ it is deemed expedient that the Council of The Corporation of the City of Barrie to further amend By-law 80-138 as amended, being a by-law to regulate traffic on highways;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law 80-138, “Schedule “L” – One Way Streets be replaced with “Schedule “L” – One Way Streets attached hereto and forming part of this by-law.
2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 8<sup>th</sup> day of September, 2015.

**READ** a third time and finally passed this 8<sup>th</sup> day of September, 2015.

**"ONE WAY STREETS"**

<u>BAYFIELD STREET</u> from Collier Street to Dunlop Street	South
<u>BRADFORD STREET</u> from High Street to Dunlop Street	North
<u>BRADFORD STREET</u> for 50' easterly from Essa Road	Westerly (81-131)
<u>CLAPPERTON STREET</u> from Dunlop Street to Collier Street	North
<u>FRED GRANT STREET</u> from Dunlop Street East to Simcoe Street	South
<u>LANE #1</u> from Collier Street to Dunlop Street East and Owen Street	South and East
<u>LANE #2</u> from Owen Street to Mulcaster Street	East
<u>LANEWAY</u> on north side of Market Square along the north side of parking lot east of City Hall	West
<u>MARKET SQUARE</u> west side of Municipal Building from Mulcaster Street to Collier Street	South
<u>MARKET SQUARE</u> east side of Municipal Building from Collier Street to Mulcaster Street	North
<u>MARY STREET</u> between Dunlop Street West and Ross Street	North
<u>SIMCOE STREET</u> from Fred Grant Street to Dunlop Street East	East and North
<u>SOPHIA STREET</u> between McDonald Street and Clapperton Street	West
