#### MILESTONES SINCE 2019 PRESENTATION TO COUNCIL

- Creation of the SCS Site Selection Advisory Committee (Fall 2019)
- Development of comprehensive site search parameters (Fall 2019) and subsequent site searches (Spring 2020 and Winter 2021)
- Completion of a multi-component community consultation
  - Fall 2020 Winter 2021
- Decision on a site to move forward for endorsement by Barrie City Council
  - Spring 2021





#### COMPONENTS OF COMMUNITY CONSULTATIONS

- Scoring of sites for most viable options for consultation (Summer 2020 and Winter 2021)
- Discussions with Council members and key stakeholders
- On-line community surveys on benefits, concerns and mitigations to address concerns (Fall 2020 and Winter 2021)
  - 1200 and 1561 respondents
  - 50 hard copy surveys from agencies that support people with lived/living experience of substance use
- Virtual neighbourhood sessions facilitated by Optimus SBR (Winter 2021)
  - 104 participants, 11 identifying as a person with lived experience of substance use

  - Proximity to potential clients
  - Proximity to sensitive land uses (as per provincial application + residential and businesses)
  - Space available
  - Building code










#### MAP OF SENSITIVE LAND USES FOR 11 INNISFIL ST
