In the report *Simcoe Muskoka Opioid Strategy: An Action Plan for Our Communities*, co-chairs Dr. Lisa Simon and Dr. Rebecca Van Iersel state that "opioid misuse, addiction and overdose in Simcoe and Muskoka is an urgent problem," adding that opioid-related death rates and emergency department visits in Simcoe Muskoka are "well above provincial averages, and continue to climb substantially."

I understand the need for urgent care and intervention to harm reduction. I support the action plan and foundation pillars in the SMOS report. I also want to acknowledge there are people in our city dying because of toxic drug poisoning that are not opiates (such as methamphetamine).

To whom it may concern,

As we wrote in a similar letter of support almost exactly two years ago, Barrie is in an opioid-related overdose crisis, and we must take action to address it, for the good of everyone who calls this city home. In the last two years, the need has only grown.

A Supervised Consumption Site (SCS) is an evidence-based response to the escalating overdose crisis that has Barrie reporting 2.5 times the provincial average of overdoses. Similar sites in other Canadian cities save lives regularly, and the proposed site will almost certainly benefit some of the people we serve at Redwood who struggle with addictions of their own.

Supervised Consumption Sites have also been shown to increase public safety in the areas that surround them, reducing the number of people injecting drugs and littering of drug-related needles in driveways and alleys nearby, which is a current concern for us at Redwood. As many others have stated, there are several consumption sites all over Barrie at the moment, none of them safe. This is a needed intervention.

Harm reduction is just one pillar of the Simcoe Muskoka Opioid Strategy (SMOS), aimed to save lives through decreasing stigma, offering the safest environment possible to consume drugs by preventing overdose and disease, and providing another, lower-barrier entry to treatment for those who are ready. While more work is needed to increase access to treatment and address the root causes of addiction, the SCS on its own will save and improve lives.

SCATEH Position Paper on Supervised Consumption Sites (SCS) and Homelessness

February 2021

The Simcoe County Alliance to End Homelessness recognizes Supervised Consumption Sites (SCS) as critical, evidence-based services, especially for marginalized populations including those experiencing homelessness.

Background

It is well documented that supervised consumption sites reduce overdose deaths - to date, there have been zero overdose deaths in an SCS worldwide. (Drug Policy Alliance, 2020) Meanwhile, more than 20,000 Canadians have died as a result of drug overdoses since 2016.

Not only do SCSs reduce overdose deaths, they also improve access to care, including addiction treatment for those who are ready. They serve as low-barrier entry points to healthcare for marginalized populations who are often dismissed from mainstream healthcare settings, and the provision of sterilized equipment reduces the spread of blood-borne infections like HIV and hepatitis C.

While public perception persists that SCSs may increase substance use and local crime and discourage individuals from seeking addiction treatment, these concerns are not supported by existing evidence. (Magwood, 2020)

SCSs and Homelessness

SCSs also reduce the number of people injecting drugs in public spaces and needles discarded in the community, when they are located in the area where public drug use is occurring. These benefits can be largely attributed to the fact that SCSs, while open to all, are especially useful for our neighbours who are unhoused and are forced to live their lives on display in public spaces.

Sometimes problematic substance use is a contributing factor in an individual becoming homeless, and sometimes those experiencing homelessness turn to drugs as a survival or coping mechanism. (Feng, 2013) Either way, high-risk substance use poses disproportionate levels of harm to those experiencing homelessness, making harm reduction approaches like SCSs particularly necessary for homeless populations. (Magwood, 2020)

The Need in Barrie

As noted by the Simcoe Muskoka District Health Unit (SMDHU), Barrie ranks third among large municipalities in Ontario for opioid overdose emergency department (ED) visit rates, behind only St. Catharines and Oshawa. The central north area of Barrie (which includes downtown) had 8 times the rate of opioid overdose ED visits in 2019 than the provincial average, and three times

the overall Barrie average. This included fifty overdose ED visits by those identifying as homeless. (SMDHU, 2020)

As an alliance to end homelessness, we advocate for everyone to have safe, affordable, stable housing and to be included in society. In the meantime, we also advocate for policy that protects those marginalized by homelessness from increased health risks, criminalization, and discrimination. For these reasons, SCATEH is in full support of a Supervised Consumption Site in downtown Barrie, where health data and research indicate it will be most useful, and accessible to those who need it most.

Re: Support for Proposed Barrie Supervised Consumption Site at 19 Innisfil St.

Barrie is in a crisis when it comes to opioid overdoses, both survivable and fatal. Barrie's high rate of overdose impacts the health of our community. I support—and wholeheartedly believe in—the need for a supervised consumption site in Barrie, Ontario, and the proposed location of 19 Innisfil St. (also known as 80 Bradford St. Unit 940).

The choice of this site is advised by the SCS Site Selection Advisory Committee, which conducts comprehensive property searches and community consultations. The applicants have determined that this site offers the best balance between effective service and acceptably fitting in with our community.

In my opinion, a vote against supervised consumption sites is a vote for needles left behind—accidentally or incidentally—where passersby can encounter them. Please help everyone by accepting the above proposal which will unquestionably reduce overdose fatalities, reduce public injecting, enhance pathways to treatment, reduce the risk of HIV and Hepatitis C from needle sharing, and promote a safer environment for the inevitable self-medication performed by people who hurt. Government should not be in the business of adding to that hurt by stripping reasonable healthcare from drug users, therefore indirectly contributing to the overdose fatalities of citizens who deserve better.

Good work has already improved the lived of drug users in our region, including work done by Simcoe Muskoka Opioid Strategy (SMOS) member agencies. They have helped to decrease the stigma of those using drugs, to increase access to treatment, to educate the community on root causes of substance use with a goal of enhancing prevention efforts, and on harm reduction practices including engaging the community via the supervised consumption site mentioned above.

I anticipate, through your sense of responsibility to your constituents, that I can look forward to seeing real change in Barrie that saves lives. Be the heroes we need: address the opioid crisis the way it needs to be—with a supervised consumption site.

Re: Support for Proposed Barrie Supervised Consumption Site at 19 Innisfil St.

Royal Victoria Regional Health Centre (RVH) is a strong supporter of developing a Safe Consumption Site in Barrie.

Over the past three years, RVH's Emergency Department has cared for almost 1,500 patients suffering an opiate overdose. Although the 2018 opening of RVH's Rapid Access Medicine (RAAM) Clinic in Barrie, as well as in Orillia, Midland and Wasaga Beach, has resulted in a 45 per cent decrease in the number of overdose patients requiring emergency care, it is still an extremely concerning health and societal issue facing our community.

After careful analysis, consideration and discussion with our team of addiction experts at RVH's Withdrawal Management Centre and the Rapid Access Addiction Medicine Clinics, RVH supports the need for a supervised consumption site in Barrie at the proposed location of 19 Innisfil St. (also known as 80 Bradford St. Unit 940).

At RVH "Safety is our Promise" and we believe that having a supervised consumption site within our community will help reduce overdose fatalities, reduce public injecting, enhance pathways to treatment, reduce the risk of HIV and Hepatitis C from needle sharing, promote a safer environment for drug use and reduce stigma associated with addiction.

The RVH Withdrawal Management Centre and the Rapid Access Addiction Medicine Clinics, located at 70 Wellington St. West, provide essential services to this vulnerable patient population. Through these programs we have come to recognize the importance of a centrally located and accessible Safe Consumption Site. As addiction is a complex disease, we understand that recovery requires a multifaceted approach and it has been our experience that easily accessible services provide the most long-term benefit to individuals maintaining recovery and remaining safe.

RVH looks forward to continuing to work with its partners in supporting our community and addressing the opioid crisis.
