## PRESENTATION CONCERNING THE DRAFT COMMUNITY SAFETY WELLBEING PLAN

Police Chief K. Greenwood provided a brief overview of the status of the draft Community Safety Well-Being Plan. Chief Greenwood introduced Alex Way from Mass LBP to provide a presentation concerning a Progress Update Report of the Barrie Community Safety and Well-Being Plan.

Mr. Way discussed slides concerning the following topics:

- An overview of the development of the Community Safety and Well-Being Plan;
- The legislative requirements related to the development of the Community Safety and Well-Being Plan;
- A chart summarizing the July 6, 2020 draft action items;
- A chart illustrating the updated and reorganized identified risk factors;

  - · Safety is for everyone; and
