RECOMMENDED MOTION

Operating Budget Approvals

- 1. That the 2024 tax-supported base operating budget for City operations and the Infrastructure Investment Fund, with gross expenditures of \$325.5 million and a net property tax levy requirement of \$191.9 million, be approved with the following amendments to reflect changes since the 2024 Business Plan's publication on November 15, 2023:
 - That the temporary position of Project Coordinator (CCI) be extended to the end of 2024 a) with a budget of \$94,828, to be recovered from capital project IT1016 (CMMS Improvement Project - Cityworks), as described in the intake form in Appendix "F" of Report to Finance and Responsible Government Committee dated November 22, 2024

City Operations and Infrastructure Investment Funding

2. That the 2024 budget request for City Operations, with a net tax supported municipal funding requirement of \$191.9 million (for the average assessed residential property this represents a 1.06% tax rate increase for City operations and a 2% increase associated with Infrastructure Investment Funding), be approved.

- 3. That the New Investment and Service Recommendations as outlined on page 20 of the 2024 Business Plan with a net cost of \$1.6 million (operating) and \$228 thousand (capital) and a net property tax levy requirement of \$925 thousand with additional funding of \$237 thousand from the water rate, \$28 thousand from the wastewater rate, \$460 thousand from capital projects, offset by \$21 thousand going towards reserves, be approved.
- 4. That the Water base Operating Budget, with gross expenditures of \$34.0 million and revenues of \$34.0 million, and the proposed 2024 Water Rates as outlined in Schedule N of the "Proposed Fee Changes" section of the 2024 Business Plan be approved.
- 5. That the Wastewater base Operating Budget, with gross expenditures of \$43.6 million and revenues of \$43.6 million, and the proposed 2024 Wastewater Rates as outlined in Schedule N of the "Proposed Fee Changes" section of the 2024 Business Plan be approved.
- 6. That the Parking Operations base budget, with gross expenditures of \$2.4 million and gross revenues of \$2.4 million, and the proposed 2024 Parking Rates as outlined in Schedule O of the "Proposed Fee Changes" section of the 2024 Business Plan be approved.
- 7. That pursuant to Ontario Regulation 284/09, Staff Report EMT005-23 serve as the method for communicating the exclusion of the following estimated expenses from the 2024 Business Plan:
 - a) Amortization expense \$ 65.5 million;
 - b) Post-employment benefit expenses \$ 1.8 million; and
 - c) Solid waste landfill closure and post-closure expenses \$ 200 thousand.

Capital Budget Approvals

- 8. That, consistent with the Capital Project Control Policy, the 2024, 2025, 2026, 2027 and 2028 Capital Budget relating to new capital spending requests of \$41.0 million, \$78.3 million, \$71.2 million, \$37.4 million, and \$24.9 million respectively be approved with the following amendments to reflect changes since the 2024 Business Plan's publication on November 15th, 2023, and the 2024-2028 Capital Budget items not requiring spending approval, be received as forecast information:
 - a) That the approved funding for IT1056 Fleet Management System be increased by \$115,000, to be funded from the Fleet Management Reserve.
 - b) That the approved funding for EN1346 Brownfield Redevelopment Readiness (Contaminated Lands Management Framework), be increased by \$130,000 to be funded from the Canada Community Building Reserve (formerly Federal Gas Tax).
 - c) That the budget of project EN1097 Mapleview Drive East Improvements, be reduced by \$120,000 funded from DC Reserves (\$96,061.18), Wastewater Capital Reserve (\$14,226.90), Tax Capital Reserve (\$5,859.45), Local Improvements Revenue (\$3,799.34) and Water Capital Reserve (\$53.12), and the budget of project EN1467 Lovers Creek Mapleview LSRCA Compensation be increased by \$120,000 funded from DC Reserves (\$54,000) and Tax Capital Reserve (\$66,000).
 - d) That a new capital project called "Waterfront 1000 Tree Planting Program" be added to the 2024 Capital Plan with a budget request of \$50,000 for 2024 and forecasts of \$50,000 per year for next 9 years to be funded from the Ecological Offsetting Reserve.

9. That any Industrial Development Charge Discounts in 2024 be funded by any year-end surplus, with any remaining balance funded from the appropriate capital reserve.

By-law update and forecasts received for information

- 10. That effective May 1, 2024, By-law 2022-013, as amended, be repealed, and replaced with a by-law incorporating the fees and charges presented in the 2024 Business Plan.
- 11. That operating forecast information for 2025, 2026, and 2027 presented in the 2024 Business Plan be received for information.

Council and Staff authorization requests

- 12. That the Executive Management Team (EMT) be authorized to add temporary non-complement positions to the end of the budget year utilizing existing approved funds to deal with any unforeseen circumstances that impact delivery of City Operations.
- 13. That the Executive Management Team (EMT) be authorized to implement the economic adjustment for the Non-Union Group (NUG) of employees (including full time, part time and students), effective January 1, 2024.
- 14. That staff be authorized to submit applications for grants that would reduce expenditures associated with projects, programs and services approved as part of the Operating and Capital Budget.
- 15. That two of the following officers: either the Mayor, Clerk, Chief Financial Officer and Treasurer or their designates, be authorized to execute any agreements that may be required to accept grant funding from other levels of government or other partners, to reduce expenditures associated with programs, services, and/or capital projects.
- 16. That staff be authorized to submit applications for grants that would reduce future capital expenditures, fund service enhancements, or enable capital projects to be advanced, and a report or memo be presented, as appropriate, prior to the execution of any agreement associated with the acceptance of such grant.
- 17. That the Chief Financial Officer and Treasurer be authorized to make the necessary alterations to the transfer to and/or from reserves to reflect changes since the 2024 Business Plan's publication on November 15th, 2023.
- 18. That the City Clerk be authorized to prepare all necessary by-laws to implement the above recommendations.

PURPOSE & BACKGROUND

Report Overview

19. The purpose of this report is to recommend the Corporation's 2024 Business Plan and Budget for City Operations. The guidelines and principles provided to Council on June 14th, 2023, in the "2024 Business Plan and Budget Directions" memorandum (provided in Appendix "A" –includes minor revisions via a memo sent on November 15th Circular list) were used by staff to create the 2024 Business Plan.

- 20. The City Operations and Infrastructure Investment Funding portions of the budget included in this report are being considered at the November 22nd, November 29th, and December 6th meeting dates. The portion of the budget related to Service Partners will be included in a separate report and will be considered at the January 17th, January 24th, and January 31st meetings in 2024.
- 21. The listing of Debenture Financing in Appendix "B" is intended to enhance transparency of approvals and make the debenture issuance process more efficient. The list contains debenture amounts for new budget requests and previously approved amounts that have yet to be issued. Forecasted debenture amounts are excluded from the listing.

Background

- 22. On July 1, 2023, the province extended the Strong Mayor, Building Homes Act to the City of Barrie. This report along with the 2024 Business Plan and Capital Plan binders provides the background to the budget the Mayor is presenting under the Strong Mayor, Building Homes Act.
- 23. On November 8, 2023, Mayor Nuttall issued a decision pursuant to the Municipal Act 2001 and Regulation 530/22 to shorten the Mayor's veto period of amendments to the budget (should he seek to utilize) from 10 days to 5 days.
- 24. On November 8, 2023, City Council approved resolution 23-A-117 to shorten the timelines for Council to override a veto of an amendment to the budget to 5 days and resolution 23-A-118 to shorten the 30-day period to pass amendments to the City of Barrie operating and capital budgets to December 6, 2023, and Service Partner budgets to January 31, 2024.
- 25. On November 15, 2023, copies of the 2024 Business Plan/Capital Plan binders were distributed to members of Council. The same information was posted on the City's website (https://www.barrie.ca/government-news/budget). A presentation will be made at the Finance and Responsible Governance meeting held on November 22, 2023, to provide an overview of the details contained within the 2024 Business Plan/Capital Plan binders.
- 26. As the details related to the City Operations annual budget and business plan/capital plans are extensive, the budget binders are intended to provide the necessary level of detail to allow members of Council to make informed decisions on its business planning for the year, as well as capital project plans.
- 27. The Executive Summary, Operating Budget and Financial Overview, and Capital Plan Overview provide details related to services provided by City operations, including proposed expenditures, and revenue sources. They also highlight significant drivers related to changes in the cost to maintain existing service levels, new investment and service recommendations, the City's financial condition, and Capital Program.

ANALYSIS

OPERATING BUDGET

28. For City Operations, the 2024 Business Plan reported a net tax levy requirement of \$185.5 million in 2024 for ongoing service delivery, excluding the Infrastructure Investment Funding (IIF) (formerly the Dedicated Infrastructure Renewal Funding (DIRF)). The net tax levy requirement, after adjusting for recommended amendments, is \$185.5 million reflecting a \$7.4 million increase over 2023 (2022 = \$178.1 million). The levy requirement incorporates the budgetary requirements of the City Operations and the New Investment and Service Recommendations.

29. The 2.00% Infrastructure Investment Funding adds an additional \$6.4 million, bringing the total recommended 2024 Tax Levy to \$191.9 million, excluding Service Partners.

Tax levy increase for City Operations is 1.06%

- 30. The tax-based budget as presented in the 2024 Business Plan binder includes a 1.06% tax rate increase for City Operations to maintain existing service levels and new investments in services for 2024. In addition, the tax-based budget includes a 2.00% tax rate increase for the IIF, representing 1% for tax-based infrastructure and 1% for stormwater infrastructure.
- 31. The extension of the temporary position of Project Coordinator (CCI) (see appendix "F" attached to Report to Finance and Responsible Governance Committee) included as part of the recommended motion to address changes since the publication of the binders, if approved, will be funded from the existing approved budget of Capital Project IT1016 CMMS Improvement project.

Water and Wastewater Rates are in line with 2021 Financial Plan Update

- 32. The Water and Wastewater budgets were developed in line with the Water and Wastewater System Financial Plan 2021 update (21-G-140), and in accordance with directions provided by Council in Motion 23-G-023 (provided in Appendix "A"). The 2021 Financial Plan update estimated the need for increases of 4% for water and 5% for Wastewater in 2023. The 2024 Business Plan and Budget is in alignment with those rates.
- 33. For a typical home that consumes 180 cubic metres annually, the annualized cost of water and wastewater services in 2024 are estimated to be \$404 and \$587 respectively for a combined cost of \$991 (\$948 in 2023). This represents a 4.5% combined increase over 2023 levels of which \$15.42 relates to water, and \$27.61 relates to wastewater.

Parking Rate revenues continue to increase post-pandemic

- 34. The 2024 Parking Operating Budget reflects the costs associated with the operations and maintenance of parking lots, parking structure and assets. The parking service is intended to be self-sustaining through user pay revenue. However, the previous operating model for the service has proven unable to generate sufficient revenue to meet the cost of annual operations on an ongoing basis.
- 35. With the approved parking strategy (20-G-168) allowing for upcoming changes to the pricing structure, the parking service financial sustainability will continue to improve with the anticipation of more people visiting the downtown and returning to the workplace.
- 36. Parking Operations continues to generate an operating deficit requiring a draw from the Parking Reserve to balance the parking budget. For 2024, the draw from the reserve is expected to be \$288 thousand, which is an improvement of \$356k over the 2023 budget and a \$1.1 million improvement over the 2022 budgeted draw.

Ontario Regulation 284/09 - Expenses not included in the 2024 Business Plan

- 37. Prior to passing the 2024 budget, municipalities are required to disclose amounts that are expensed in their financial statements (full accrual accounting), but not included in budgeted figures (modified accrual accounting). For the City of Barrie this includes three estimated expenses:
 - Amortization expense \$65.5 million;
 - Post-employment benefit expenses \$1.8 million; and
 - Solid waste landfill closure and post-closure expenses \$200 thousand.

CAPITAL BUDGET

5-Year plan from 2024 - 2028 forecasts \$1.32B in spending for growth and asset renewal

- 38. The 2024 Capital plan is \$691 million, including carryforwards of \$169 million, \$269.0 million in previously approved funding, \$252.8 million in new funding requests, and \$224 thousand associated with New Investment and Service Recommendation Operating Budget requests. Details of the 2024 Capital Budget are found in the 2024 Capital Plan binder.
- 39. Consistent with the Capital Project Financial Control Policy, where the 2024 Capital Budget includes projects that will be completed over more than one reporting period, Council's approval of new projects in the 2024 Capital Budget would include approval of the funds required in 2024, 2025, 2026, 2027 and 2028 to conduct the work, totaling \$252.8 million.
- 40. In addition to the portion of the 2024 Capital Budget that is recommended for approval, the 2024-2028 Capital Plan provides a forecast for capital spending over the next five years. The 2024-2028 Capital Plan includes \$1.32 billion in spending and was developed with a focus on addressing the City's most critical asset renewal needs, areas currently experiencing service level deficiencies, and required investment to support the growth management process. It should be noted that despite the significant investment being made, many important projects were deferred. As aging assets fail, their ability to deliver service to the community will be impacted.

Additional budget required for existing projects

- 41. Through the 2021 capital plan, project IT1056 Fleet Management System was approved, with \$175,000 to procure an updated software tool to manage the City's fleet. Procurement was recently completed, and the lowest compliant bid is over the approved budget of \$175,000, due to unforeseen price increases. In order to award the contract, an additional \$115,000 is required.
- 42. Council had previously approved project EN1346- Brownfield Redevelopment Readiness (Contaminated Lands Management Framework) with a budget of \$100,000 to procure a consultant to prepare the city for the development, ownership, and flow-through implications of contaminated lands. Two rounds of procurement were recently completed, including a clarification of assignment objectives and scope reduction to bring the project within the approved budget. Despite the changes, the lowest compliant bid remains over the approved budget of \$100,000, mainly due to the availability of specialized expertise required to complete the work and inflationary pressures. To award the contract, an additional \$130,000 is required.
- 43. A transfer of \$120,000 of budget from EN1097 Mapleview Drive East Improvements to project EN1467 Lovers Creek Mapleview LSRCA Compensation is being requested in the 2024 capital plan:
 - a) EN1097 This project was for widening of Mapleview Drive (Country Lane to Yonge) Phase 4 from two to five lanes including storm sewers, transmission watermain, multi-use path, and street lighting. The project is in warranty.
 - b) EN1467 This project is for LSRCA compensation measures for Mapleview widening Phase 3 – Huronia Road to Country Lane to construct a pedestrian bridge over a Lover's Creek Tributary. The need to accommodate vehicular loading on the bridge for maintenance, resulted in additional design considerations and requirements to satisfy operational needs and regulatory authority requirements.

44. In accordance with the Council approved Waterfront Strategic Plan Update and as per motions 23-G-207 and 23-G-242, a new "Waterfront 1000 Tree Planting Program" capital project is to be added to the 2024 Business Plan to plant 1,000 trees along the waterfront over the next (10) years starting in 2024 to be funded from the Ecological Offsetting Reserve. A budget of \$50,000 is to be allocated annually starting in 2024 through 2033 from the reserve with the goal of planting a minimum of 100 trees annually on the waterfront. Additionally, as per the approved Ecological Offsetting Policy, Development Services staff will as Priority One, target that a minimum of 50% of the trees planted citywide as part of ecological offsetting restoration projects will be planted on the waterfront until the 1000 trees planted target is achieved.

DC Discounts for specific uses have no budget set aside and are estimated at \$1.5M

- 45. The City's 2019 DC-Bylaw 2019-055, which was in effect up until June 20th, 2023, provided for a 40% Development Charge discount for specific uses. As is required under the Development Charge Act, these Development Charge discounts must be funded from alternative sources.
- 46. The 2023 DC Bylaw no longer provides for the 40% Development Charge discount for specific uses. There are, however, some developments that have received site plan approval under the previous bylaw, and therefore these discounts will continue for a few more years. There is no budget set aside to fund these discounts. Historically, the discounts have amounted to approximately \$2 million.
- 47. For the 2023 year-end, it is expected the City must fund \$1.5 million of such discounts, with \$1.0 million relating to the Tax Rate (which includes Stormwater), \$210 thousand relating to the Water Rate, and \$236 thousand relating to the Wastewater Rate.
- 48. The City's Financial Policy Framework recommends any year end surplus be allocated to the City's Capital Reserves to support needed capital renewal works. Relying on funding of DC discounts through year end surpluses and Capital Reserves further reduces the City's ability to complete needed renewal works.

STAFF AUTHORITY REQUESTS

To be able to add positions due to Unforeseen Circumstances

- 49. To ensure delivery of City Operations and the 2024 Business Plan and Budget it is recommended that the Executive Management Team (EMT) have the authority to add temporary non complement positions to address unforeseen events, such as new service demands, project workload and staff absences.
- 50. As identified in the City's Human Resource Complement Management procedure, the following rules would apply to such temporary non complement positions:
 - a) Funds must be available in the budget year to fund the position;
 - b) Length of term will not extend beyond that budget year;
 - c) Salary gapping targets must still be met for that budget year;
 - Appropriate approvals by way of Human Resources forms must be completed;
 - e) Any exceptions to the above will be reviewed by the Chief Administrative Officer in consultation with all members of EMT;
 - f) Departments will be required to prepare a memo for Council to outline the details of the position should the need to extend beyond the budget year as directed by EMT; and
 - g) The funding for these positions will not form part of the next year's base operating budget unless approved by Council in the form of a motion.

To implement economic adjustments for Non-Union Group (NUG) Employees

51. The City is party to various collective agreements negotiated with its unionized workforce. An agreement with the Canadian Union of Public Employees (CUPE) is in place for 2024. Budgeted labour costs reflect known and anticipated obligations for collective agreements, and an economic adjustment for Non-Union Group (NUG) labour costs.

Budget Engagement Summary showed interest in maintaining spending in many areas

52. Access Barrie collaborated with Finance to educate and engage the public throughout the 2024 Business Plan and Budget process. Feedback was solicited through two online surveys hosted on the City's engagement platform BuildingBarrie.ca and a statistically valid phone survey conducted by Oraclepoll Research. The engagement opportunities were promoted through a marketing campaign that took place from September 25 – October 20, 2023.

Online Surveys were performed for City Operations & Service Partners

- 53. Two online surveys were created asking residents to provide feedback on major services included in the City's annual operating budget and the Service Partner budgets. Respondents had the option to increase, decrease or maintain spending for each area and learn about the service impacts associated with each choice. The goal of the surveys was to improve understanding of how tax dollars are spent and basic municipal budgeting processes, demonstrate value for money and get input from the public on key service areas.
- 54. The surveys closed with a total of 660 submissions (513 submissions to the City Operations Survey and 174 submissions to the Service Partners Survey). On each service area, respondents could increase spending by 5%, maintain current spending, or decrease spending by 5%. A summary of results and comments is included in Appendix "C". Overall trends in the data show the most popular selection for most service areas was to "Maintain current spending". The exception was the Barrie Police Service where the most popular selection was to "Increase spending 5%". Respondents were required to provide an email address, username and postal code to complete the online surveys. The results are not statistically valid.

The Phone Survey was Statistically Valid

- 55. The City worked with Oraclepoll Research to conduct a statistically valid phone survey of residents to gather feedback on key questions related to the 2024 Business Plan & Budget. The phone survey included 1,000 Barrie residents from all 10 Wards (both cellular and landlines). A summary of results is included in Appendix D.
- In addition to the surveys, staff executed a marketing campaign with the objectives of creating awareness on how the City spends tax dollars, and encouraging residents to submit their feedback via the surveys. The campaign included, but was not limited to, media releases, radio ads, digital and social media ads (X, Facebook, Instagram), updates to Barrie.ca, e-bulletins, digital facility screens and print ads in This Week in Barrie.
- 57. As of October 20, 2023, City-originated social media posts and ads about the 2024 budget generated more than 150 thousand combined impressions.
- 58. As part of the educational campaign, staff also included the opportunity for Barrie homeowners to review a personalized 'taxpayer receipt' that provided an estimated breakdown of how their 2023 tax dollars were used to fund City and partner services.

ENVIRONMENTAL AND CLIMATE CHANGE IMPACT MATTERS

59. There are no environmental or climate change impact matters directly related to the recommendation. The 2024 Business Plans and Budgets reflect various initiatives and capital projects that support a more sustainable community, features that mitigate climate change risks, and measures that promote adaptation to climate change.

Adjustments to bring City Services increase down from 1.06% to 0%

- 60. Appendix 'E' highlights possible reductions to the budget that could be made to bring the tax rate increase down to 0%. Many of the changes proposed are either reductions in service or a delay in hiring staff.
- 61. Finance and Responsible Governance Committee could reduce the tax levy increase by accepting some or all the proposed budget reduction measures highlighted in Appendix 'E'. The impacts of initiating these changes will not be seen immediately, but as lower service levels begin to take effect it will result in budget pressures in future years.
- 62. In particular, the delay in hiring firefighters originally slated to join the City in 2024 will result in a pressure of \$1.2 million in 2025 if these positions are pushed out to next year's budget.

- 63. The following motions may be considered if Council would like to reduce the 2024 budget with items included in Appendix 'E':
 - a) That budget reductions totaling \$154,000 for the CAO and Mayor's Division, as outlined in Appendix 'E' of Report to Finance and Responsible Governance Committee dated November 22, 2023, be included in the 2024 budget, with an equivalent decrease in the 2024 Tax Levy
 - b) That budget reductions totaling \$451,742 for the Access Barrie Division, as outlined in Appendix 'E', of Report to Finance and Responsible Governance Committee dated November 22, 2023, be included in the 2024 budget, with an equivalent decrease in the 2024 Tax Levy
 - c) That budget reductions totaling \$430,331 for the Infrastructure & Growth Management Division, as outlined in Appendix 'E', of Report to Finance and Responsible Governance Committee dated November 22, 2023 be included in the 2024 budget, with an equivalent decrease in the 2024 Tax Levy
 - d) That budget reductions totaling \$2,348,040 for the Community & Corporate Services Division, as outlined in Appendix 'E', of Report to Finance and Responsible Governance Committee dated November 22, 2023 be included in the 2024 budget, with an equivalent decrease in the 2024 Tax Levy
 - e) That the Chief Financial Officer be allowed to adjust the budget reductions in Appendix 'E' of Report to Finance and Responsible Governance Committee dated November 22, 2023 as necessary to achieve a 0% tax rate increase on City Operations, excluding the Infrastructure Investment Funding and Service Partners.

ALTERNATIVES

64. The following are alternatives available for consideration by Finance and Responsible Governance Committee:

Alternative #1

Finance and Responsible Governance Committee could reduce the tax levy increase related to City Operations to 0% by increasing the draw from reserves by \$3,384,113.

This alternative is not recommended as it increases the reliance on reserves by funding a larger portion of City operations from reserves. The City's reserves are not sufficient to continue such draws and will create a tax levy pressure in future years when the subsidy is reduced.

Alternative #2:

Finance and Responsible Governance Committee could reduce the Infrastructure Investment Funding tax increase from 2% to 1% by increasing the draw from the Reinvestment Reserve by \$3,205,000.

This alternative increases the reliance on reserves by funding a larger portion of City operations from the Reinvestment Reserve and will create a tax levy pressure in future years when this subsidy is reduced.

Currently the Reinvestment Reserve is projected to be in a deficit position at the end of 2024. The main reason for this is that it is funding \$4.9 million of City Operations via the Growth Strategy introduced in the 2020 budget, as well as the Council motions to utilize the reserve to reduce the tax levy in 2021, 2022 and 2023.

Alternative #3:

Finance and Responsible Governance Committee could increase the tax levy from 1.06% to 2.59%. This would remove the \$4.9 million of funding from the Reinvestment Reserve that is used to offset the tax rate.

Staff support this alternative as it will remove a large annual draw from the Reinvestment Reserve, an important reserve for the City. Also, it will result in the City's revenues covering expenditures without drawing from reserves, and so will improve the long-term financial sustainability of the City. It has not been recommended due to staff's recognition of the affordability concerns in the community associated with this level of tax levy increase.

FINANCIAL

65. The financial impacts of the 2024 Business Plan are addressed in the analysis section of this report.

LINKAGE TO 2022-2026 COUNCIL STRATEGIC PLAN

- 66. The recommendations in this staff report are aligned to each of the five priorities identified in the 2022-2026 Council Strategic Plan.

- 4. That staff prepare the 2024 Business Plan for rate supported services that includes:
 - a) Recommendations for changes to user fees that reflect the full cost of providing the program or service, including fixed assets, net of any subsidy approved by Council; and,
 - b) Contributions to reserves that are consistent with the Financial Policies Framework and Council direction that reflect, to the extent possible, the anticipated current and future commitments against the reserves.
- 5. That any significant impacts to the 2024 budget be presented for consideration, including:
 - a) new investments and changes in level of service;
 - b) changes in staff complement levels; and
 - c) user fees that are added, removed, or increased/decreased by 5% or more.

Reduce police fund by 10%. The City is spending too much on wages for a service quality that is poor. This is not a defund the police remark, this comes from personal experience regarding car break-in, lack of effort to address the problem, one on one engagement with rude front counter staff (not officers). Also the lack of addressed illegal settlements by the homeless population, making for unsafe public spaces.

Perhaps we should look into building a permanent tiny home camp to house the homeless and create a program that sets them up with counselling, addictions programs, and education/training/ jobs. You can't fight addiction until you treat the underlying cause for using. You can't keep a job if you're addicted or without a roof over your head. We need a plan not just haphazard shelters and nonprofit programs that can't keep up.

Transit requires a major overhaul. Downtown Barrie needs to be cleaned up and revitalized without surrounding the bay with super high-rise towers. We do not have the doctors, hospital capacity or other emergency service capacity to support the extent of development proposed for downtown. I don't mind paying higher taxes to keep Barrie safe, vibrant and in good order but spend our money wisely. Methodology & Logistics

Background & Overview

The following represents the findings from an October 2023 telephone survey of N=1000 voting age City of Barrie residents (18 years of age or older) conducted by Oraclepoll Research Limited for The City of Guelph. The purpose of the research was to gather opinions from residents on issues related to the 2023 City budget process.

This report includes an executive summary of the findings and the results by question, while a separate Excel file contains the results by question.

Study Sample

A dual frame random database (RDD) was used for the sample that was inclusive of landline and cellular telephone numbers. The sample was stratified to ensure that there was an equal distribution across each of the ten City Wards. The survey screened to ensure respondents were 18 years of age or older and were residents of each Ward. Gender and age samples were also monitored to ensure they reflected the demographic characteristics of the community.

Survey Method

All surveys were conducted by telephone using live operators at the Oraclepoll call center facility. A total of 20% of all interviews were monitored and the management of Oraclepoll Research Limited supervised 100%. The survey was conducted using computer-assisted techniques of telephone interviewing (CATI) and random number selection (RDD).

Logistics

Surveys were conducted by telephone at the Oraclepoll call center using person to person live operators from the days of October 18th to October 26th, 2023.

Initial calls were made between the hours of 6:00 p.m. and 9:00 p.m. Subsequent call-backs of noanswers and busy numbers were made on a (staggered) daily rotating basis up to 5 times (from 10:00 a.m. to 9:00 p.m.) until contact was made. In addition, telephone interview appointments were attempted with those respondents unable to complete the survey at the time of contact. If no contact was made at a number after the fifth attempt, the number was discarded and a new one supplanted it.

Confidence

The margin of error for the total N=1000 sample is $\pm 3.1\%$ at the 95% confidence interval. Error rates for sub-groups of the population (demographics) vary and are higher.

Top of Mind Issue

In the first question presented to all N=1000 respondents, they were asked in an open-ended or unaided probe to name what they considered to be the main issue facing the City of Barrie.

Q1. What in your opinion is the main issue facing the City of Barrie at this time?

Issues related to rising costs including the cost of living or inflation (26%) and housing costs (13%) and its related theme of availability dominated, closely followed by responses of drugs or specifically opioids (21%) and the related theme of crime, safety, or drug violence (11%). Other notable responses included transit, infrastructure, and the economy along with the social themes of homelessness, poverty, and mental health.

Tolerance for Higher Taxes

The following short descriptive statement was first read to all respondents after which they were asked if they would be willing to pay higher taxes to maintain service levels for City services and Service Partners.

"While the City of Barrie provides many services for its residents and businesses, it also faces high inflation costs while delivering these services. In order to maintain existing service levels, would you be willing to pay slightly higher taxes for each of the following?





Responses were mixed with 43% being willing to pay slightly higher taxes for City Services, while 48% are not, with 9% being unsure. Those responding yes tended to be in the mid aged cohorts of 30-39 (51%), 40-49 (52%) and 50-59 (48%) and in the higher income brackets of \$75,000-\$99,999 (76%) and \$100,000+\$ (75%).

Q2B. Service Partners (County, Police, Library)



Somewhat fewer or 38% said they are willing to pay slightly higher taxes for Service Partners, with more than half or 51% not willing, while 11% were uncertain. Once again yes results were elevated for those aged 30-39 (55%), 40-49 (49%) and 50-59 (48%) as well as those earning \$75,000-\$99,999 (73%) and \$100,000+ (78%).



RVH Special Tax Levy

In the next probe, respondents were probed to find out if they would support a special tax levy to assist in the future expansion of the Royal Victoria Hospital.

Q3. Would you support a special tax levy dedicated to help fund the expansion of the Royal Victoria Hospital (RVH)?



There was a three-way split of responses with 31% answering yes they are willing to support the special levy, only 37% in opposition while nearly a third were unsure requiring more information.

Results of unsure were higher among older residents (70+, 39% & 60-69, 40%), while those 70+ were most likely to have said no (48%). Conversely those more inclined to respond yes were aged 40-49 (44%), 30-39 (40%), 50-59 (37%) and 18-29 (30%). Higher earners making \$75,000-\$99,999 (63%) and \$100,000+ (59%) also had higher yes mentions.





Taxation vs Services Received

All N=500 residents were then asked if the taxes they pay to the City were fair in relation to the services received.

Q4. In your opinion, are the taxes you pay to the City of Barrie fair in relation to the services you receive?



Residents were divided with 44% answering that the taxes they pay are fair in relation to the services they receive and 46% responding no. Ten percent were unsure or undecided. Older residents 70+ (77%) and 60-69 (69%) had the highest mentions of no, compared to those under the age of 60 that were more likely to answer yes (30-39, 58% / 40-49, 57% / 50-59, 51% / 18-29, 43%). No responses were also highest among those earning under \$50,000 per annum (75%) and \$50,000-\$74,999 (59%). Those earning \$75,000-\$99,999 (73%) and \$100,000+ (75% were most satisfied answering yes.
